EMERGENCY CLAUSE. It is found and determined by the General 23 Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a two (2) year period; that the 24 25 effectiveness of this Act on July 1, 2001 is essential to the operation of the 26 agency for which the appropriations in this Act are provided, and that in the event of an extension of the Regular Session, the delay in the effective date 27 of this Act beyond July 1, 2001 could work irreparable harm upon the proper 28 29 administration and provision of essential governmental programs. Therefore, an 30 emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full 31 32 force and effect from and after July 1, 2001.
