23	(b)(1) Any person eligible to vote by absentee ballot may request the				
24	county clerk to mail to an address within the continental United States an				
25	application for an absentee ballot.				
26	(2)(A) For those persons voting by absentee ballot who reside				
27	outside the county in which they are registered to vote or in long-term care				
28	or residential facilities licensed by the state, or who are disabled voters				
29	as defined in § 7-5-311, the application shall remain in effect for one (1)				
30	year unless revoked by the voter, and the county clerk shall thereafter				
31	automatically mail, no later than twenty-five (25) days prior to each				
32	election, an absentee ballot for each election.				
33	(B) Except for persons of long-term care or residential				
34	facilities licensed by the state or other persons who are disabled voters as				
35	defined in § 7-5-311(d), for those persons voting by absentee ballot who				
36	reside within the county in which they are registered to vote, the
