### For An Act To Be Entitled

9 AN ACT TO AUTHORIZE THE ESTABLISHMENT OF A  
10 FOUNDATION FOR EARLY CHILD CARE AND EDUCATION;  
11 AND FOR OTHER PURPOSES.

13 AN ACT TO AUTHORIZE THE ESTABLISHMENT OF

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
20

21 SECTION 1. Arkansas Code 20-78-205 is amended to add an additional  
22 subsection to read as follows:

23 (d)(1) In addition to any other rights, powers, functions, and duties  
24 granted by law to the Department of Human Services, Division of Child Care and  
25 Early Childhood Education, the department is hereby authorized to promote and  
26 cooperate in the establishment of a foundation under the Arkansas nonprofit  
27 corporation law, and to accept support and assistance in the form of money,  
28 property, or otherwise from the foundation to be used to enhance quality,  
29 affordability, and availability of child care and early education for all  
30 children in the state.

31 (2) If a foundation is established for the early care and  
32 education of children and the Department of Human Services shares resources or  
33 facilities with the foundation or accepts support and assistance from the  
34 foundation, the foundation shall annually file a report with the Governor, the  
35 Legislative Council, and the Legislative Joint Auditing Committee showing the  
36 amount and source of all gifts, grants, and donations of money or property

1 received by the foundation and all expenditures or other dispositions of money  
2 or property by the foundation during the preceding year.

3 (3) The Director of the Department of Human Services, Division of  
4 Child Care and Early Childhood Education shall, after consultation with the  
5 Arkansas Early Childhood Commission, prepare rules for the use of foundation  
6 funds. The director shall submit the proposed rules to the Legislative  
7 Council for its review.

8 (4) No person over whom the Department of Human Services has day-  
9 to-day managerial control shall receive compensation or remuneration from  
10 funds not in the State Treasury.
