For An Act To Be Entitled

9 AN ACT TO AMEND ARKANSAS CODE 11-9-102 TO PROVIDE THAT
10 A MOTOR CARRIER SHALL NOT BE DEEMED THE "EMPLOYER" OF
11 A LEASED-OPERATOR OR OWNER-OPERATOR OF A MOTOR VEHICLE
12 OR VEHICLES UNDER WRITTEN CONTRACT TO THE MOTOR
13 CARRIER UNDER THE ARKANSAS WORKERS' COMPENSATION LAW;
14 AND FOR OTHER PURPOSES.

17 PROVIDE THAT A MOTOR CARRIER SHALL NOT
18 BE DEEMED THE "EMPLOYER" OF A LEASED-
19 OPERATOR OR OWNER-OPERATOR OF A MOTOR
20 VEHICLE OR VEHICLES UNDER WRITTEN
21 CONTRACT TO THE MOTOR CARRIER UNDER THE
22 ARKANSAS WORKERS' COMPENSATION LAW.

25 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

27 SECTION 1. Arkansas Code 11-9-102(10) is amended to read as follows:

28 (10) "Employer" means any individual, partnership, limited
29 liability company, association, or corporation carrying on any employment, the
30 receiver or trustee of the same, or the legal representative of a deceased
31 employer; provided that no motor carrier shall be deemed the "employer" of a
32 leased-operator or owner-operator of a motor vehicle or vehicles under a
33 written contract to such a motor carrier.

35 SECTION 2. Arkansas Code Title 11, Chapter 9, Subchapter 1 is amended
36 to add an additional section to read as follows:

1 11-9-118. A leased-operator or owner-operator under a written contract
2 with a motor carrier may elect to be covered and have the leased-operator's or
3 owner-operator's drivers covered under a workers' compensation policy or
4 authorized self-insurance that insures the motor carrier if the leased-
5 operator or owner-operator pays the premiums as requested by the motor
6 carrier. An election by a leased-operator or owner-operator under this
7 section does not terminate the independent contractor status of the leased-
8 operator or owner-operator for any purpose other than the purpose of this
9 section.
