- 24 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA HELP
- 25 EXEMPTION. Extra Help positions authorized herein are specifically exempt
- 26 from limitation of hours, either by act or regulation. Provided, however,
- 27 when a temporary or part-time employee is employed by the Department of
- 28 Finance and Administration Revenue Services for a period of time exceeding
- 29 seven (7) months, a report of such shall be filed with the Arkansas
- 30 Legislative Council. The provisions of this section shall be in effect only
- 31 from July 1, 2001 through June 30, 2003.

- 33 SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
- 34 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL
- 35 RATES OF PAY. Due to the highly competitive job market conditions for tax
- 36 auditing professionals and the necessity of recruiting and retaining qualified

personnel, the Revenue Division Office of Field Audit is authorized special rates of pay for current and new employees in the classification listed under subsection (a) below.

(a) Special rates may be authorized up to the maximum authorized for the grade assigned the classification of a position for the following specific classifications only:

(b) Applications for <u>A plan for providing</u> special rates of pay indicated in subsection (a) shall be reviewed by and approved by the Office of Personnel Management <u>and receive advice of the Legislative Council each year.</u>

(c) This provision shall be in full force and effect for the biennium beginning July 1, 1999 2001, and ending June 30, 2001 2003.

SECTION 22. SPECIAL LANGUAGE NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY FORWARD - COMMERCIAL DRIVERS LICENSE PROGRAM. The unexpended balances in the appropriations provided in Item (04) of Section 5 remaining on June 30, 2002, may be carried forward and used for the same purpose during the fiscal year ending June 30, 2003. The provisions of this section shall be in effect only from July 1, 2001 through June 30, 2003.

 SECTION 23. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. <u>FUND BALANCES</u>. (A) For all appropriations as provided in this Act, the agency disbursing officer shall

- 1 monitor the level of fund balances in relation to expenditures on a monthly
- 2 <u>basis</u>. If any proposed expenditures would cause a fund balance to decline to
- 3 <u>less than fifty percent (50%) of the balance available on July 1, 2001, the</u>
- 4 <u>disbursing officer shall immediately notify the executive head of the agency.</u>
- 5 Prior to any obligations being made under these circumstances, the agency
- 6 <u>head shall file written documentation with the Chief Fiscal Officer of the</u>
- 7 State requesting approval of the expenditures. Such documentation shall
- 8 provide sufficient financial data to justify the expenditures and shall
- 9 <u>include the following:</u>
- 10 1) a plan that clearly indicates the specific fiscal impact of such

- 16 4) a statement certifying that the expenditure of fund balances will not
- 17 <u>jeopardize the financial health of the agency, nor result in a permanent</u>
- 18 depletion of the fund balance.
- 19 (B) The Chief Fiscal Officer of the State shall review the request and
- 20 approve or disapprove all or any part of the request, after having sought
- 21 prior review by the Legislative Council.

- 23 SECTION 24. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
- by this act shall be limited to the appropriation for such agency and funds
- 25 made available by law for the support of such appropriations; and the
- 26 restrictions of the State Purchasing Law, the General Accounting and Budgetary
- 27 Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures

9	effectiveness of this Act on July 1, 2001 is essential to the operation of the
10	agency for which the appropriations in this Act are provided, and that in the
11	event of an extension of the Regular Session, the delay in the effective date
12	of this Act beyond July 1, 2001 could work irreparable harm upon the proper
13	administration and provision of essential governmental programs. Therefore, an
14	emergency is hereby declared to exist and this Act being necessary for the
15	immediate preservation of the public peace, health and safety shall be in full
16	force and effect from and after July 1, 2001.
