- (j) All funds received by the *University of Arkansas at Pine Bluff* from
 the repayment of scholarship awards by program participants shall be deposited
 in the fund that provides funding for the Critical Needs Minority Teacher
 Scholarship Program.
- 15 <u>(k)(1) The University of Arkansas at Pine Bluff</u> shall make an annual 16 report to the General Assembly.
