21 SECTION 2. EMERGENCY CLAUSE. It is hereby found and determined by the

- 22 General Assembly, that changes in fiscal laws for the 2001-03 Biennium have
- 23 to take effect on July 1, 2001 and that in the event of an extension of the
- 24 Regular Session, the delay in the effective date of this Act beyond July 1,
- 25 2001 could work irreparable harm upon the proper administration and provision
- 26 <u>of essential governmental programs</u>. Therefore, an emergency is hereby
- 27 declared to exist and this Act being necessary for the immediate preservation
- 28 of the public peace, health and safety shall be in full force and effect from
- 29 and after July 1, 2001.
