19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code 27-50-906 is amended to read as follows:
22 27-50-906. Furnishing of abstracts.

23 (a) The Office of Driver Services may furnish an abstract or driver
24 confirmation record of any driver's record to:

- 25 (1) The driver on whom the record has been compiled;
26 (2) Any person who has been authorized in writing by the driver
27 to obtain the driver's record;
28 (3) Any court having jurisdiction over traffic offenses;
29 (4) Any law enforcement officer, who shall use the report only
30 in the line of duty in enforcing the traffic laws of this state;
31 (5) Employers of drivers, provided that the driver has given his
32 written consent for the employer to obtain the driver's record;
33 (6) Any insurer licensed to do business in Arkansas or its
34 agents, employees, or contractors in connection with the driving record or
35 driver confirmation record of an insured or applicant, and all licensed
36 drivers in the household of the insured or applicant;

1 (7)(A) Any governmental department or agency upon a showing of
2 reasonable cause as to why the driver's record should be issued to the
3 governmental department or agency in order for the governmental department or
4 agency to effectively carry out its statutory duties.

5 (B) No driver's record shall be reported to any individual
6 except duly authorized officials of the office unless a copy of the report
7 and the name of the individual or organization which received the report are
8 sent to the driver named in the report; and

9 (8) A driver's license status report shall be available to
10 rental car companies who otherwise meet the requirements of this section for
11 receiving an abstract of a driver's record upon the payment of one dollar
12 (\$1.00) for each license number checked. This fee shall be deposited to the
13 State Treasury into the State Central Services Fund as a direct revenue to be
14 used by the Revenue Division of the Department of Finance and Administration.
15 The Information Network of Arkansas may charge an additional fee for the
16 service of transmitting this information electronically.

17 (b) For purposes of this section, "driver confirmation record" means
18 information in the Office of Driver Services concerning the name, date of
19 birth, and current address of the licensed driver.

20 (c) The fee for an insureds or applicants driver confirmation record
21 shall be ten cents (10¢) per record. This fee shall be deposited into the State
22 Central Services Fund as a direct revenue to be used by the Revenue Division
23 of the Department of Finance and Administration. The Information Network of
24 Arkansas may charge an additional fee for the service of transmitting this
25 information electronically.
