19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code Title 10, Chapter 3, is amended by adding the
22 following additional subchapter:

23 10-3-1801. Creation.

24 There is established the Arkansas State Game and Fish Commission
25 Oversight Committee of the General Assembly which shall have the authority to
26 conduct an interim study into the long-term funding needs and potential long-
27 term financial sources for the Arkansas State Game and Fish Commission.
28

29 10-3-1802. Membership.

30 (a) The Arkansas State Game and Fish Commission Oversight Committee
31 shall consist of nine (9) members from the Senate appointed by the President
32 Pro Tempore and nine (9) members of the House of Representatives appointed by
33 the Speaker of the House.

34 (b) Members of the committee shall be entitled to per diem and mileage
35 for attending meetings of the committee at the same rate as is provided by
36 law for members of the joint interim committees and such per diem and mileage

1 shall be paid from funds appropriated for payment of per diem and mileage of
2 members of joint interim committees.

4 10-3-1803. Duties.

5 The Arkansas State Game and Fish Commission Oversight Committee shall
6 examine possible methods to increase the potential revenue for the Arkansas
7 State Game and Fish Commission and make recommendations for legislation to
8 the Governor and to the General Assembly.

32 ~~Commission and shall make any necessary recommendations for legislation to~~
33 ~~the Governor and to the 80th General Assembly.~~

34 ~~SECTION 2.—The Speaker of the House may appoint two (2) members of the~~
35 ~~House of Representatives as additional members to the Arkansas Game and Fish~~
36 ~~Commission Funding Study Subcommittee.—One (1) additional member shall be~~

1 ~~female and one (1) member shall be a member of a racial minority. The~~
