AN ACT TO CREATE THE TASK FORCE ON
METHAMPHETAMINE; AND FOR OTHER PURPOSES.

Subtitle

AN ACT TO CREATE THE TASK FORCE ON
METHAMPHETAMINE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. (a) There is created the Task Force on Methamphetamine.

(b) The task force shall be composed of the following members"

(1)(A) Two (2) members of the Senate Committee on Judiciary
appointed by the President Pro Tempore of the Senate;

(B) Two (2) members of the House Committee on Judiciary
appointed by the Speaker of the House;

(2)(A) Two (2) members of the Senate Committee on Public Health
Welfare and Labor appointed by the President Pro Tempore of the Senate; and

(B) Two (2) members of the House Committee on Public
Health Welfare and Labor appointed by the Speaker of the House; and

(3) One (1) member appointed by the Prosecutor Coordination
Commission;

(4) One (1) member appointed by the Arkansas Sheriffs
Association to represent the association;

(5) One (1) member appointed by the Consumer Healthcare Products
Association;

(6) One (1) member appointed by the Oil Marketers Association;

1 (7) One (1) member appointed by the Arkansas Pharmaceutical
2 Association;

3 (8) One (1) member appointed by Arkansas Rehabilitation
4 Services;

5 (9) One (1) member appointed by the Retailers Association;

6 (10) Any manufacturer or wholesaler of pharmaceutical drugs that
7 does business in the state may choose to appoint a member to represent the
8 manufacturer or wholesaler; and

9 (11) Any other involved entity may choose a member to represent
10 those involved entities.

11 (c)(1) The President Pro Tempore of the Senate shall designate one (1)
12 Senate member of the task force as the Senate cochair of the committee.

13 (2) The Speaker of the House shall designate one (1) House
14 member of the task force as the Senate cochair of the committee.

15
16 SECTION 2. (a) The task force shall present its final report to the
17 General Assembly no later than November 1, 2002.

18 (b) This report shall include:

19 (1) The activities of the task force;

20 (2) The findings of the task force;

21 (3) Any recommendations for programs, policies, or proposed
22 legislation of the task force; and

23 (4) Any other information the task force considers appropriate.
