18	SECTION 2. <u>Prohibition.</u>		
19	(a) It is unlawful for any person less than twenty-one (21)		
20	years of age to perform any dance, striptease, or other performing act		
21	<u>harmful</u>		
22	to youth which involves nudity or sexual conduct, in public or for-hire.		
23	(b) It is unlawful for any person to employ or allow a person less		
24	<u>than</u>		
25	twenty-one (21) years of age to perform the acts specified in subsection (a)		
26	of this section.		
27			
28	SECTION 3. <u>Penalties.</u>		
29	Any person convicted of violating this act shall be guilty of:		
30	(1) A misdemeanor, upon a first offense, punishable by the		
31	imposition of a fine not to exceed one hundred dollars (\$100), or by		
32	imprisonment in the county jail not to exceed thirty (30) days, or both;		
33	(2) A mi sdemeanor, upon a second offense, puni shable by the		
34	imposition of a fine not to exceed five hundred dollars (\$500), or by		
35	imprisonment in the county jail not to exceed six (6) months, or both; or		
36	(3) A felony, upon a third or subsequent offense, punishable by		

1	the imposition of a fine not to exceed one thousand dollars (\$1,000), or by
2	imprisonment in the state penitentiary not to exceed five (5) years, or by
3	both fine and imprisonment.
4	
5	SECTION 4. <u>Juveniles.</u>
6	(a)(1) A violation of this act shall not be a basis for instituting
7	juvenile proceedings to determine if a person under eighteen (18) years of
8	age is a delinquent child;
9	(2) However, if a person under eighteen (18) years of age
10	violates this act on two (2) or more occasions, juvenile proceedings may be
11	brought to determine if the person is a delinquent child.
12	(b) A person under eighteen (18) years of age who has been adjudicated
13	as an adult and convicted of violating this act may be subject to the penalty
14	provisions provided in this act.
