## For An Act To Be Entitled

9 AN ACT TO AMEND ARKANSAS CODE 21-6-307 TO  
10 INCREASE THE FEES CHARGED FOR THE SERVICES OF THE  
11 COUNTY SHERIFF'S OFFICE; AND FOR OTHER PURPOSES.

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. Arkansas Code 21-6-307(a), concerning the fees charged for  
21 services of the county sheriff's office, is amended to read as follows:

22 (a) The following fees shall be charged by each of the sheriffs of the  
23 several counties of the State of Arkansas:

24 (1) For serving every summons, capias, scire facias, attachment,  
25 writ of garnishment, writ of injunction, or subpoena.....~~\$ 15.00~~ \$ 30.00

26 (2) For serving a writ of execution .....~~50.00~~ 100.00

27 (3) For commission for receiving and paying money on execution  
28 or process when lands or goods have been taken into custody, advertised, or  
29 sold .....~~7%~~ 10%

30 (4) For every return of a writ, summons, or subpoena, original  
31 or judicial .....~~10.00~~ 20.00

32 (5) For executing a writ of inquiry .....~~10.00~~ 20.00

33 (6) For executing a certificate of purchase for real estate  
34 under execution .....~~10.00~~ 20.00

35 (7) For making, executing, and subscribing a sheriff's deed to  
36 be paid by purchaser .....~~15.00~~ 30.00
