9	<u>insurance</u> policy or contract may provide a more affordable health insurance		
10	policy for you, although at the same time, it will provide you with fewer		
11	health benefits coverages than those normally imposed on health insurance		
12	policies in Arkansas. If you select this option, please first consult with		
13	your insurance agent to discover the degree to which the alternative health		
14	insurance policy or contract does not provide health and medical benefits		
15	equal to those policies subject to state mandated health benefits. If you are		
16	eligible for a health insurance policy, your insurance agent may offer you an		
17	alternative health insurance policy or health plan not fully subject to state		
18	mandated benefits.
