19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code 5-3-203 is amended to read as follows:

22 5-3-203. Classification. A criminal attempt is a:

23 (1) Class Y felony if the offense attempted is capital murder;

24 ~~(1)(2) Class A felony if the offense attempted is capital murder,~~
25 treason, or a Class Y felony;

26 ~~(2) (3) Class B felony if the offense attempted is a Class A felony;~~

27 ~~(3) (4) Class C felony if the offense attempted is a Class B felony;~~

28 ~~(4) (5) Class D felony if the offense attempted is a Class C felony;~~

29 ~~(5) (6) Class A misdemeanor if the offense attempted is a Class D~~
30 ~~felony or an unclassified felony;~~

31 ~~(6) (7) Class B misdemeanor if the offense attempted is a Class A~~
32 ~~misdemeanor;~~

33 ~~(7) (8) Class C misdemeanor if the offense attempted is a Class B~~
34 ~~misdemeanor;~~

35 ~~(8) (9) Violation if the offense attempted is a Class C misdemeanor or~~
36 ~~an unclassified misdemeanor.~~

2 SECTION 2. Arkansas Code 5-3-301(b), concerning conduct constituting
3 criminal solicitation, is amended to read as follows:

4 (b) Criminal solicitation is a:

5 (1) Class Y felony if the offense solicited is capital murder;

6 ~~(1) (2)~~ Class A felony if the offense solicited is ~~capital~~
7 ~~murder~~, treason, or a Class Y felony;

8 ~~(2) (3)~~ Class B felony if the offense solicited is a Class A
9 felony;

10 ~~(3) (4)~~ Class C felony if the offense solicited is a Class B
11 felony;

12 ~~(4) (5)~~ Class D felony if the offense solicited is a Class C
13 felony;

14 ~~(5) (6)~~ Class A misdemeanor if the offense solicited is a Class
15 D felony or an unclassified felony;

16 ~~(6) (7)~~ Class B misdemeanor if the offense solicited is a Class
17 A misdemeanor;

18 ~~(7) (8)~~ Class C misdemeanor if the offense solicited is a Class
19 B misdemeanor;

20 ~~(8) (9)~~ Violation if the offense solicited is a Class C
21 misdemeanor or an unclassified misdemeanor.

23 SECTION 3. Arkansas Code 5-3-404 is amended to read as follows:

24 5-3-404. Classification.

25 Criminal conspiracy is a:

26 (1) Class Y felony if an object of the conspiracy is the commission of
27 capital murder;

28 ~~(1) (2)~~ Class A felony if an object of the conspiracy is commission of
29 ~~capital murder~~, treason, or a Class Y felony;

30 ~~(2) (3)~~ Class B felony if an object of the conspiracy is commission of
31 a Class A felony;

32 ~~(3) (4)~~ Class C felony if an object of the conspiracy is commission of
33 a Class B felony;

34 ~~(4) (5)~~ Class D felony if an object of the conspiracy is commission of
35 a Class C felony;

36 ~~(5) (6)~~ Class A misdemeanor if an object of the conspiracy is

1 commission of a Class D felony or an unclassified felony;
2 ~~(6)~~ (7) Class B misdemeanor if an object of the conspiracy is
3 commission of a Class A misdemeanor;
4 ~~(7)~~ (8) Class C misdemeanor if an object of the conspiracy is
5 commission of a Class B misdemeanor.
