23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24

25 SECTION 1. Arkansas Code 26-57-236(g), as amended by Act 434 of 1997,
26 pertaining to stamp deputies, is amended to read as follows:

27 (g) A commission shall be paid by the director to stamp deputies for the
28 sales and collection of cigarette tax stamps and for affixing the said tax
29 stamps to each package of cigarettes. The commission shall not be less than
30 ~~four and four tenths percent (4.4%)~~ three and eight tenths percent (3.8%) of
31 the total aggregate cigarette tax collected.

33 SECTION 2. Arkansas Code 26-57-1103, pertaining to the distribution of
34 the proceeds of an additional tobacco tax, is amended to read as follows:

35 ~~Ten percent (10%)~~ Twenty nine percent (29%) of all moneys collected from
36 the additional tax levied in §§26-57-1101 and 26-57-1102 shall be deposited

1 in the State Treasury as ~~general revenues~~ special revenue, 50% of which shall
 2 be credited to the Aging and Adult Services Fund Account of the Department of
 3 Human Services Fund to be used to assist the Meals-on-Wheels program; and 50%
 4 of which shall be credited to the Department of Human Services Grants Fund
 5 Account to be used to implement a Prescription Drug for the Elderly Waiver
 6 Program. In the event, however, that the federal government implements a
 7 prescription drug assistance program that provides essentially the same
 8 benefits or greater to the same eligible clients as the Prescription Drug
 9 Waiver for the Elderly Program, the funds set aside herein for the
 10 Prescription Drug Waiver for the Elderly Program shall be credited, in lieu
 11 thereof, to the Breast Cancer Control Fund and to the Breast Cancer Research
 12 Fund in the same proportions as set out in Arkansas Code 26-57-1106(a).

 14 SECTION 3. Arkansas Code 26-57-1106 concerning the distribution of
 15 funds for breast cancer research and control, is amended to read as follows:

 17 26-57-1106. Distribution of funds for breast cancer research and control -
 18 Allocation of moneys.

 20 (a) ~~Ninety percent (90%) of all~~ All remaining moneys collected from
 21 the additional tax levied in §§ 26-57-1101 and 26-57-1102 shall be deposited
 22 in the State Treasury as special revenues to be distributed as follows:

23 (1) Twenty percent (20%) shall be credited to the Breast Cancer
 24 Research Fund, which is hereby created on the books of the State Treasurer,
 25 State Auditor and the Chief Fiscal Officer of the State to be used
 26 exclusively for the purposes set forth in ~~§ 20-15-303~~ §20-15-1303; and

27 (2) Eighty percent (80%) shall be credited to the Breast Cancer
 28 Control Fund which is hereby created on the books of the State Treasurer,
 29 State Auditor and the Chief Fiscal Officer of the State to be used
 30 exclusively for the purposes set forth in ~~§ 20-15-304~~ §20-15-1304 and, at the
 31 option of the Department of Health in an amount not to exceed the amount
 32 appropriated by the General Assembly for such purpose, for cervical cancer
 33 control. The Director of the Department of Health shall be the disbursing
 34 officer for the Breast Cancer Control Fund and the Chancellor of the
 35 University of Arkansas for Medical Sciences shall be the disbursing officer
 36 for the Breast Cancer Research Fund.
