9 AN ACT TO ESTABLISH THE CONGRESSIONAL DISTRICTS  
10 IN ARKANSAS; AND FOR OTHER PURPOSES.

### Subtitle

12 AN ACT TO ESTABLISH THE CONGRESSIONAL  
13 DISTRICTS IN ARKANSAS.

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 *SECTION 1. Arkansas Code 7-2-102 is amended to read as follows:*  
20 *7-2-102. First Congressional District.*

21 *The First Congressional District shall be composed of the counties of:*  
22 *Arkansas, Clay, Cleburne, Craighead, Crittenden, Cross, Desha, Fulton,*  
23 *Greene, Independence, Izard, Jackson, Jefferson, Lawrence, Lee, ~~Lonoke~~,*  
24 *Mississippi, Monroe, Phillips, Prairie, Poinsett, Randolph, St. Francis,*  
25 *~~Searcy~~, Sharp, Stone, and Woodruff; and the qualified electors residing*  
26 *therein shall elect one (1) member of the House of Representatives of the*  
27 *United States.*

28  
29 *SECTION 2. Arkansas Code 7-2-103 is amended to read as follows:*  
30 *7-2-103. Second Congressional District.*

31 *The Second Congressional District shall be composed of the counties of:*  
32 *Conway, Faulkner, Lonoke, ~~Perry~~, Pope, Pulaski, ~~Saline~~, Searcy, Van Buren,*  
33 *and White, ~~and Yell~~; and the qualified electors residing therein shall elect*  
34 *one (1) member of the House of Representatives of the United States.*

36 *SECTION 3. Arkansas Code 7-2-104 is amended to read as follows:*

1 7-2-104. Third Congressional District.

2 The Third Congressional District shall be composed of the counties of:  
3 Baxter, Benton, Boone, Carroll, Crawford, Franklin, Johnson, ~~Logan,~~ Madison,  
4 Marion, Newton, ~~Polk, Pope,~~ Sebastian, Scott, and Washington; and the  
5 qualified electors residing therein shall elect one (1) member of the House  
6 of Representatives of the United States.

7  
8 SECTION 4. Arkansas Code 7-2-105 is amended to read as follows:

9 7-2-105. Fourth Congressional District.

10 The Fourth Congressional District shall be composed of the counties of:  
11 Ashley, Bradley, Calhoun, Chicot, Clark, Cleveland, Columbia, Dallas, ~~Desha,~~  
12 Drew, Garland, Grant, Hempstead, Hot Spring, Howard, ~~Jefferson,~~ Lafayette,  
13 Little River, Lincoln, Logan, Miller, Montgomery, Nevada, Ouachita, Perry,  
14 Pike, Polk, Saline, Sevier, ~~and~~ Union, and Yell; and the qualified electors  
15 residing therein shall elect one (1) member of the House of Representatives  
16 of the United States.
