24	including Wal-Mart Stores and Tyson Foods, which have huge fleets of trucks
25	and trailers that are now registered in other states outside of Arkansas; and

27	WHEREAS, Arkansas is the home state for many trucking firms, including
28	firms like J.B. Hunt and ABF Trucking, and they also register most of their
29	trucks and trailers in states outside of Arkansas; and
30	
31	WHEREAS, the motor carrier business is a mobile business and it is easy
32	for it to move from location to location and take with it the jobs that
33	employ people and the salary dollars that drive our economy; and
34	
35	WHEREAS, there are many Arkansans who are over-the-road drivers and
36	owner-operators of trucks and trailers, and keeping those jobs and salary

1	dollars in Arkansas is of major economic interest for the State of Arkansas,

3	NOW THEREFORE,
4	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-THIRD GENERAL
5	ASSEMBLY OF THE STATE OF ARKANSAS, THE SENATE CONCURRING THEREIN:

7	That the House Interim Committee on Public Transportation and the
8	Senate Interim Committee on Public Transportation are requested to study the
9	practice of out-of-state truck registration by trucking firms resident to
10	Arkansas, and to determine if revisions of law or other incentives will cause
11	trucks resident to Arkansas to return their registration to Arkansas and to
12	make recommendations in the form of proposed legislation to the Eighty-Fourth
13	General Assembly of Arkansas in January, 2003.
