

4	NOW THEREFORE,				
5	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-THIRD GENERAL				
6	ASSEMBLY OF THE STATE OF ARKANSAS, THE SENATE CONCURRING THEREIN:				
7					
8	(1) That the Regular Session of the Eighty-third General Assembly of				
9	the State of Arkansas is extended until 12:00 Noon, May 14, 2001;				
10	(2) That the Regular Session of the Eighty-third General Assembly of				
11	the State of Arkansas shall enter into recess at the close of business on				
12	April 13, 2001, or at such earlier time as may be agreed upon by the Senate				
13	and the House of Representatives; and				
14	(3) That the President Pro Tempore of the Senate and the Speaker of				
15	the House of Representatives may, by joint proclamation:				
16	(A) Reconvene the General Assembly at any time before 12:00 Noon,				
17	May 14, 2001, for the purpose of:				
18	(i) Considering vetoes;				
19	(ii) Correcting errors and oversights;				
20	(iii) Completing its work on proposed constitutional				
21	amendments, including but not limited to any constitutional amendment or				
22	amendments dealing with public school finance which may be needed or required				
23	as a result of a court decision in the pending litigation involving the				
24	Lakeview School District;				
25	(iv) Considering House Bill 2373, Senate Bill 810, Senate				
26	Bill 812, Senate Concurrent Resolution 14, Senate Concurrent Resolution 15,				
27	Senate Concurrent Resolution 16, and Senate Concurrent Resolution 17 relating				
28	to implementation of recommendations of the National Conference of State				
29	Legislatures concerning the Arkansas General Assembly; and				
30	(v) Considering the need for further extension of the				
31	Regular Session of the Eighty-third General Assembly; or				
32	(B) Adjourn the Regular Session of the Eighty-third General				
33	Assembly at any time before that date if they determine it is not necessary				
34	to reconvene.				
35	(4) That if the General Assembly is not reconvened or adjourned before				
36	12:00 Noon, May 14, 2001, the Regular Session of the Eighty-third General

1	Assembly is adjourned sine die on that date.
