20	WHEREAS, individuals with developmental disabilities are important to
21	the people of the State of Arkansas; and

23	WHEREAS, the Arkansas definition of "developmental disability" is based
24	on a categorical approach specifying the presence of cerebral palsy,
25	epilepsy, autism or mental retardation under § 20-48-101; and
26	
27	WHEREAS, the federal definition of "developmental disability" is
28	primarily based on a functional approach, under 45 U.S.C. § 6001(8); and
29	
30	WHEREAS, there has not been a comprehensive comparison of Arkansas and
31	federal laws concerning individuals with developmental disabilities since
32	1988; and
33	WHEDEAS a study should be made to determine the most for charges in

36	Arkansas law in order to provide reasonably reliable estimates of the number of persons in Arkansas who satisfy the current Arkansas definition of

5	changes needed to better serve Arkansas' individuals with developmental
6	disabilities so that individuals with disabilities other than autism, mental
7	retardation, cerebral palsy and epilepsy might also be eligible for publicly-
8	supported services.

12	ASSEMBLY OF THE STATE OF ARKANSAS:

15	study the need to amend Arkansas law pertaining to the definition of
16	developmental disability.
