

SECTION 2. APPROPRIATION - LEGISLATIVE ASSISTANCE. There is hereby
appropriated, to the Office of the Governor, to be payable from the
Constitutional Officers Fund, for personal services and operating expenses of
the Office of the Governor for the fiscal year ending June 30, 2001, the

SECTION 3. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE 14 15 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. LIAISONS 16 AUTHORIZED. The Governor is hereby authorized to employ three (3) Legislative Liaisons who shall serve without pay but shall be entitled to per diem of one 17 18 hundred and fifty dollars (\$150.00) for each day the General Assembly is in 19 regular session. After receiving approval of the Governor, the Department of 20 Finance and Administration - Management Services Division is hereby authorized 21 to process payments to said Liaisons from funds authorized by this Act. 22 23 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE

NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. <u>PAYMENT OF</u>
<u>SALARIES AND PER DIEM</u>. <u>Salaries and per diem as authorized in Section 1 and 3</u>
of this Act shall be in effect from and after January 8, 2001.

SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by 28 29 this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions 30 31 of the State Purchasing Law, the General Accounting and Budgetary Procedures 32 Law, the Revenue Stabilization Law, the Regular Salary Procedures and 33 Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of 34 35 Finance and Administration, as authorized by law, shall be strictly complied 36 with in disbursement of said funds.

2 SECTION 6. LEGISLATIVE INTENT. It is the intent of the General Assembly 3 that any funds disbursed under the authority of the appropriations contained 4 in this act shall be in compliance with the stated reasons for which this act 5 was adopted, as evidenced by the Agency Requests, Executive Recommendations 6 and Legislative Recommendations contained in the budget manuals prepared by 7 the Department of Finance and Administration, letters, or summarized oral 8 testimony in the official minutes of the Arkansas Legislative Council or Joint 9 Budget Committee which relate to its passage and adoption.

11 SECTION 7. EMERGENCY CLAUSE. It is found and determined by the General 12 Assembly, that the Constitution of the State of Arkansas prohibits the 13 appropriation of funds for more than a two (2) year period; that the 14 effectiveness of this Act on the date of its passage and approval is essential 15 to the operation of the agency for which the appropriations in this Act are 16 provided, and that in the event of an extension of the Regular Session, the 17 delay in the effective date of this Act beyond the date of its passage and 18 approval could work irreparable harm upon the proper administration and 19 provision of essential governmental programs. Therefore, an emergency is 20 hereby declared to exist and this Act being necessary for the immediate 21 preservation of the public peace, health and safety shall be in full force and 22 effect from and after the date of its passage and approval. 23 If the bill is neither approved nor vetoed by the Governor, it shall become effective on the expiration of the period of time during which the Governor 24 25 may veto the bill. If the bill is vetoed by the Governor and the veto is 26 overridden, it shall become effective on the date the last house overrides the 27 veto. 28 29 30 31 32 33 34
