It is the intent of the General Assembly 6 7 that any funds disbursed under the authority of the appropriations contained 8 in this act shall be in compliance with the stated reasons for which this act 9 was adopted, as evidenced by the Agency Requests, Executive Recommendations 10 and Legislative Recommendations contained in the budget manuals prepared by 11 the Department of Finance and Administration, letters, or summarized oral 12 testimony in the official minutes of the Arkansas Legislative Council or Joint 13 Budget Committee which relate to its passage and adoption.

15	SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General		
16	Assembly, that the Constitution of the State of Arkansas prohibits the		
17	appropriation of funds for more than a two (2) year period; that the		
18	effectiveness of this Act on July 1, 2001 is essential to the operation of th		
19	agency for which the appropriations in this Act are provided, and that in the		
20	event of an extension of the Regular Session, the delay in the effective date		
21	of this Act beyond July 1, 2001 could work irreparable harm upon the proper
