## For An Act To Be Entitled

9 AN ACT TO PROVIDE FOR THE ISSUANCE OF VETERANS LICENSE  
10 PLATES; AND FOR OTHER PURPOSES.  
11

### Subtitle

12 AN ACT TO PROVIDE FOR THE ISSUANCE OF  
13 VETERANS LICENSE PLATES.  
14

16  
17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
18

19 SECTION 1. The Director of the Department of Finance and Administration  
20 shall provide for and issue special Armed Forces Veteran license plates. The  
21 license plates shall be issued in the manner and subject to the conditions  
22 prescribed in this act.  
23

24 SECTION 2. The license plates shall be of standard color and design as  
25 is currently issued by the Department of Finance and Administration, except  
26 that, in lieu of the legend "The Natural State" or any succeeding legend, the  
27 license plates shall have placed across the bottom thereof a permanent decal  
28 bearing the words "Armed Forces Veteran".  
29

30 SECTION 3. Upon payment of the fee required by law for registration of  
31 the vehicle, payment of an additional ten dollar (\$10.00) handling and  
32 administrative fee for the issuance of a special license plate, and  
33 presentation of proof of being eligible for a special Armed Forces Veteran  
34 license plate, the Department of Finance and Administration shall issue the  
35 appropriate special license plate to the vehicle owner. The handling and  
36 administrative fee of ten dollars (\$10.00) shall be deposited in the State

1 Central Services Fund for the benefit of the Revenue Division of the  
2 Department of Finance and Administration and shall be credited to the Revenue  
3 Division as supplemental and in addition to all other funds as may be  
4 deposited for the benefit of the Revenue Division. The handling and  
5 administrative fee shall not be considered or credited to the Revenue Division  
6 as "direct revenues".

7  
8 SECTION 4. Special Armed Forces Veteran License plates issued under  
9 this act may be renewed annually at the regular fee. Registration may  
10 continue from year to year as long as it is renewed each year within the time  
11 and manner required by law.

12  
13 SECTION 5. Special Armed Forces Veteran License plates issued under  
14 this act may be transferred from one vehicle to another pursuant to Arkansas  
15 Code 27-14-914.

16  
17 SECTION 6. The Director of the Department of Finance and Administration  
18 shall promulgate such reasonable rules and regulations and prescribe such  
19 forms as he determines to be necessary for effectively and efficiently  
20 carrying out the intent and purposes of this act.

21  
22 SECTION 7. Only persons who receive an honorable discharge from a  
23 branch of the United States Armed Forces shall be eligible for the special  
24 Armed Forces Veteran license plate established by this act.
