Arkansas Code 19-6-482 is amended to read as follows: 24 25 19-6-482. Telecommunications Equipment Fund. 26 The Telecommunications Equipment Fund shall consist of those special revenues as specified in subdivision (129) of § 19-6-301. The fund shall be 27 used exclusively by the Office of the Deaf and Hearing Impaired of the 28 29 Division of Vocational and Technical Education of the Department of Education 30 Arkansas Rehabilitation Services to fund an equipment distribution program for 31 persons certified as deaf, hard of hearing, deaf and blind, or speech-impaired 32 as provided otherwise in § 20-79-401 et seg. 33 SECTION 2. Arkansas Code 20-79-401 is amended to read as follows: 34 35 20-79-401. Statewide program established. 36 (a)(1) The Office for the Deaf and Hearing Impaired of Arkansas

- 1 Rehabilitation Services is hereby directed to establish, administer, staff,
- 2 and promote a statewide program to provide access to public telecommunications
- 3 services by residents of Arkansas who are deaf, hard of hearing, deaf and
- 4 blind, and others such as the severely speech-impaired or who have other
- 5 disabilities that impair their ability to effectively access the
- 6 <u>telecommunication network</u>. This program will enable these individuals to
- 7 <u>access specialized devices or services for telecommunication network access</u>
- 8 that is functionally equivalent to that enjoyed by individuals without
- 9 <u>disabilities</u>.

- (2) This program shall include, but is not limited to:
- 11 (A) The purchase and distribution of telecommunications
- 12 devices and related devices for the persons who are deaf, hard of hearing,
- 13 deaf and blind, and for others who are severely speech-impaired or who have
- 14 <u>other disabilities that impair their ability to effectively access the</u>
- 15 <u>telecommunication network</u>;
- (B) The promulgation of procedures, regulations, rules, and criteria necessary to implement and administer this program, including accountability measures which utilize consumer participation in the selection and evaluation of equipment and the eligibility of applicants; and
 - (C) Other actions as may be necessary to implement and administer this program which are not otherwise prohibited by law.
 - (b) The Office for the Deaf and Hearing Impaired Arkansas

 Rehabilitation Services shall employ at least one (1) full-time staff person to administer the equipment distribution program and may employ any additional support personnel for the program from within existing staff resources to assure statewide coverage for the program.

- SECTION 3. Arkansas Code 20-79-402(a) is amended to read as follows:
- (a) In order for a person to be eligible for the equipment distribution program, a person shall be certified as deaf, hard of hearing, deaf and blind, or speech-impaired, or having another disability that impairs the individual's ability to effectively access the telecommunication network by a licensed physician, audiologist, or speech pathologist or by any other method recognized by the Office for the Deaf and Hearing Impaired Arkansas Rehabilitation Services.

1	SECTION 4. Arkansas Code 20-79-403(a)(1) & (2) are amended to read as
2	follows:
3	(a)(1) Equipment purchased under this subchapter shall remain the
4	property of the State of Arkansas <u>for two (2) years and then become the</u>
5	property of the recipient of the equipment.
6	(2) A person who receives the equipment shall be responsible for
7	the maintenance of the equipment and liable to the Office for the Deaf and
8	Hearing Impaired Arkansas Rehabilitation Services for the loss of or damage to
9	the equipment.
