FUND BALANCES. (A) For all appropriations as provided in this Act, the agency disbursing officer shall 24 25 monitor the level of fund balances in relation to expenditures on a monthly 26 basis. If any proposed expenditures would cause a fund balance to decline to 27 less than fifty percent (50%) of the balance available on July 1, 2001, the 28 disbursing officer shall immediately notify the executive head of the agency. 29 Prior to any obligations being made under these circumstances, the agency head 30 shall file written documentation with the Chief Fiscal Officer of the State

SECTION 39. APPROPRIATION - INDUSTRIAL COORDINATOR PROGRAM. There is hereby

COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized 12 by this act shall be limited to the appropriation for such agency and funds 13 made available by law for the support of such appropriations; and the 14 restrictions of the State Purchasing Law, the General Accounting and Budgetary 15 Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures 16 and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of 17 18 Finance and Administration, as authorized by law, shall be strictly complied 19 with in disbursement of said funds. 20 SECTION 42. LEGISLATIVE INTENT. 30 SECTION 43. EMERGENCY CLAUSE. It is found and determined by the General 31 Assembly, that the Constitution of the State of Arkansas prohibits the 32 appropriation of funds for more than a two (2) year period; that the 33 effectiveness of this Act on July 1, 2001 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the 34 event of an extension of the Regular Session, the delay in the effective date 35 36 of this Act beyond July 1, 2001 could work irreparable harm upon the proper

1	administration and provision of essential governmental programs. Therefore, an
2	emergency is hereby declared to exist and this Act being necessary for the
3	immediate preservation of the public peace, health and safety shall be in full
