### **For An Act To Be Entitled**

9 AN ACT TO ESTABLISH THE EIGHTY-THIRD SESSION  
10 PROJECTS ACCOUNT WITHIN THE GENERAL IMPROVEMENT  
11 FUND; TO DEFINE THE MONIES TO BE AVAILABLE IN  
12 SUCH ACCOUNT; AND TO DEFINE THE PURPOSES FOR  
13 WHICH MONIES MAY BE MADE AVAILABLE FROM THE  
14 GENERAL IMPROVEMENT FUND; AND FOR OTHER PURPOSES.

### **Subtitle**

16 THE DISTRIBUTION OF THE EIGHTY-THIRD  
17 SESSION PROJECTS ACCOUNT OF THE GENERAL  
18 IMPROVEMENT FUND.

20  
21

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. This Act may be cited as the "General Improvement  
25 Distribution Act of 2001".  
26

27 SECTION 2. There is hereby created and established on the books of the  
28 Chief Fiscal Officer of the State, the State Treasurer and the State Auditor,  
29 the "83rd Session Projects Account" within the "General Improvement Fund",  
30 into which shall be transferred and credited the respective monies as  
31 hereinafter provided in this Act, to be used for providing financing, in the  
32 manner set forth herein, for the various projects and purposes enumerated in  
33 this Act to be financed from said account.

34 Immediately upon the effective date of this Act, or as soon thereafter  
35 as is practical, the State Treasurer shall transfer and credit to the "83rd  
36 Session Projects Account" of the "General Improvement Fund", upon

1 certification of the amounts thereof by the Chief Fiscal Officer of the  
2 State, the following:

3 (a) all unobligated and unallocated monies remaining in the "General  
4 Improvement Fund" *on June 30, 2001* which are not required to finance  
5 projects to be financed therefrom pursuant to appropriations enacted by the  
6 82nd General Assembly, or which have not been reappropriated or reallocated  
7 for financing from the "General Improvement Fund" by the 83rd General  
8 Assembly;

9 (b) any unobligated or unallocated funds remaining in the "General  
10 Revenue Allotment Reserve Fund" from monies accruing thereto during the 1999-  
11 2001 fiscal biennium which are not required to finance enactments of the 83rd  
12 General Assembly that do not expire on June 30, 2001;

13 (c) interest earned on State Treasury fund balances as provided in  
14 this subsection. For the period commencing on July 1, 2001, and ending June  
15 30, 2003, the State Treasurer shall, after complying with provisions of

16 (1) Arkansas Code 27-70-204 for distributing interest income  
17 earned from investment of average daily balances of the "State Highway and  
18 Transportation Department Fund",

19 (2) Arkansas Code 15-41-110 for distributing interest earned  
20 from investment of average daily balances of the "Game Protection Fund",

21 (3) Arkansas Code 15-5-422 for the first two million dollars  
22 (\$2,000,000) of interest income received each fiscal year by the State  
23 Treasurer as authorized for the Correction Facilities Construction Fund, and

24 (4) Arkansas Code 20-78-504 for the next one hundred thousand  
25 dollars (\$100,000) of interest income received each fiscal year by the State  
26 Treasurer for the Arkansas Child Care Facilities Loan Guarantee Trust Fund,  
27 credit to the "Budget Stabilization Trust Fund" or its successor fund, fifty  
28 percent (50%) of the interest income received and credited to the "Securities  
29 Reserve Fund", and credit to the "83rd Session Projects Account" fifty  
30 percent (50%) of the interest income received and credited to the "Securities  
31 Reserve Fund" as certified by the Chief Fiscal Officer of the State, to  
32 provide financing to the "83rd Session Projects Account", until there has  
33 been credited an amount, which when added to the other funds available for  
34 such purposes will finance each of the projects or purposes hereinafter  
35 enumerated;

36 (d) all balances on June 30, 2001 in the Economic Development of

1 Arkansas Fund exceeding \$7,500,000 prior to any other transfer authorized  
2 from the Economic Development of Arkansas Fund on July 1, 2001;

3 (e) monies credited to the General Improvement Fund for the period  
4 beginning July 1, 2001 and ending December 31, 2001 from the Estate tax under  
5 the provisions of Arkansas Code 26-59-122(a);

6 (f) the balance of the Economic Development of Arkansas Fund on  
7 December 31, 2001;

8 (g) six million dollars (\$6,000,000) which the Director of the  
9 Department of Finance and Administration shall deposit into the General  
10 Improvement Fund from the fund balances of the State Employees Benefit Trust  
11 Fund of the State and Public School Employees Insurance Fund;

12 (h) funds which shall be deposited by the various elected  
13 constitutional officers from accounts held outside the State Treasury that  
14 are not fiduciary and are not restricted in their use by law or court order  
15 as follows:

16 (1) From accounts of the Commissioner of State Lands, the sum of  
17 \$2,000,000;

18 (2) From accounts of the Office of Attorney General, Secretary  
19 of State and Auditor of State the amount of funds as are available which  
20 conform to the criteria of this subsection on July 1, 2001 and as determined  
21 by the Division of Legislative Audit of the Legislative Joint Audit  
22 Committee.

23  
24 SECTION 3. Of those moneys accruing to the 83rd Session Projects  
25 Account of the General Improvement Fund as set out in Section 2 of this Act,  
26 the State Treasurer shall distribute the proceeds as follows:

27 (a) The Treasurer of State shall first make monthly allocations on the  
28 basis of 50% of the total available funds to the Executive Discretionary  
29 Division as set out in subsection (c) and 50% of the total available funds to  
30 the Legislative Division listed in subsection (b) until all projects  
31 enumerated in subsection (b) have been fully funded. The Legislative Division  
32 funds shall be used to provide funds to each project enumerated in this  
33 section in proportion that each project's allocation bears to the total of  
34 the allocations of all projects enumerated in subsection (b). Additional  
35 funds that may be received by the General Improvement Fund after the projects  
36 in subsection (b) have been fully funded shall remain in the General

1 *Improvement Fund for such purpose as may be enacted by law, but shall not be*  
 2 *a part of the 83<sup>rd</sup> Session Projects Account. Funds made available to the*  
 3 *Executive Discretionary Division may be used for any project or portion*  
 4 *thereof enumerated within the Executive Discretionary Division but not to*  
 5 *exceed the amount set out in subsection (c) for the project. The Chief Fiscal*  
 6 *Officer of the State shall notify the Legislative Council of the Governor's*  
 7 *released funds for projects at the same time that the Department of Finance*  
 8 *and Administration is notified.*

22       SECTION 4. DISBURSEMENT OF FUNDS. Expenditure of the funds authorized  
 23 by the Eighty-third General Assembly from the 83rd Session Projects Account  
 24 shall be made only upon documentation to the Chief Fiscal Officer of the  
 25 State, in such form as deemed necessary, that all criteria or pre-conditions  
 26 established in the appropriation act have been met or in the case of state  
 27 agencies, and that a Method of Finance has been filed with the Office of  
 28 Accounting in the Department of Finance and Administration, if required. Any  
 29 matching funds as may be provided in law shall be certified to the Chief  
 30 Fiscal Officer of the State prior to the commencement of the project.  
 31 Further, any recipient of the funds appropriated herein may be required to  
 32 file a compliance audit indicating that the use of the funds was in  
 33 compliance with the intent of the General Assembly.

34  
 35       SECTION 5. Any enactment of the 83rd General Assembly appropriating or  
 36 allocating funds to be payable from the "General Improvement Fund", for which

1 a specific allocation of funds is specifically authorized in this Act, shall  
2 be deemed to be payable from the "83rd Session Projects Account" within the  
3 "General Improvement Fund" unless a specific intent is otherwise provided by  
4 law. Any enactment of the 83rd General Assembly appropriating funds payable  
5 from the General Improvement Fund which is not enumerated in this Act shall  
6 not be financed from monies accruing to the 83rd Session Projects Account.  
7 Provided that monies reappropriated by the 83rd General Assembly for projects  
8 for which appropriations were made by the 82nd General Assembly, which are  
9 not enumerated in this Act and which are made payable from the "General  
10 Improvement Fund", shall be payable from the "82nd Session Projects Account"  
11 of the "General Improvement Fund" and allowances shall be made therefore in  
12 arriving at the uncommitted and unobligated balance of monies in the "General  
13 Improvement Fund" before making transfers therefrom to the "83rd Session  
14 Projects Account", as authorized by this Act.

15

16 SECTION 6. Distribution of funds for constructing and equipping the  
17 radiation therapy institutes specified herein, shall be contingent upon the  
18 provision of matching funds, including those monies previously raised but not  
19 previously used to match state funds, on a dollar by dollar basis on behalf  
20 of each such radiation therapy institute.

21

22 SECTION 7. CONTINGENCY TRANSFER. Five million eight hundred eighty  
23 five thousand one hundred forty seven dollars (\$5,885,147) shall be  
24 transferred from the Industry and Aerospace Development Fund to the General  
25 Improvement Fund to be used as determined by the General Assembly in the  
26 event that the commitment approved by the Industry and Aerospace Commission  
27 on March 29, 2001 is declined by the prospective corporation.

28

29 SECTION 8. APPROPRIATION. *There is hereby appropriated, to the*  
30 *Department of Higher Education, to be payable from the General Improvement*  
31 *Fund, for providing student scholarships through the Governor's Scholars*  
32 *Program by the Department of Higher Education for the biennial period ending*  
33 *June 30, 2003, the sum of \$2,200,000.*

34

35 SECTION 9. SPECIAL LANGUAGE. *NOT TO BE INCORPORATED INTO THE ARKANSAS*  
36 *CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.*

1 ADDITIONAL TRANSFER AUTHORITY. Any transfer restrictions contained in  
2 appropriation acts for the Department of Higher Education relating to  
3 appropriation transfers from Governor's Scholars Program and Academic  
4 Challenge Scholarships shall not be applicable to transfers between  
5 Governor's Scholars and Academic Challenge Scholarship appropriations.

6  
7 SECTION 10. This Act shall not be incorporated into the Arkansas Code  
8 nor published separately as Special, Local and Temporary Law.

9  
10 SECTION 11. EMERGENCY CLAUSE. It is found and determined by the  
11 General Assembly that it has considered and enacted appropriations for  
12 construction projects and other programs to be financed from the accumulated  
13 surplus and reserve funds available in the State Treasury; that the total of  
14 the enacted appropriations exceed the estimated available funding available  
15 for such projects and that the immediate passage of this Act is necessary to  
16 establish a method of providing for the orderly financing and a system of  
17 priority for the financing of such projects. Therefore, an emergency is  
18 declared to exist and this act being immediately necessary for the  
19 preservation of the public peace, health and safety shall become effective on  
20 the date of its approval by the Governor. If the bill is neither approved  
21 nor vetoed by the Governor, it shall become effective on the expiration of  
22 the period of time during which the Governor may veto the bill. If the bill  
23 is vetoed by the Governor and the veto is overridden, it shall become  
24 effective on the date the last house overrides the veto.
