## For An Act To Be Entitled

9 AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES  
10 AND OPERATING EXPENSES FOR THE ARKANSAS LIVESTOCK AND  
11 POULTRY COMMISSION WHICH SHALL BE SUPPLEMENTAL AND IN  
12 ADDITION TO THOSE FUNDS APPROPRIATED BY ACT 1183 OF  
13 1999; AND FOR OTHER PURPOSES.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. REGULAR SALARIES - GENERAL OPERATIONS. There is hereby  
25 established for the Arkansas Livestock and Poultry Commission - General  
26 Operations the following maximum number of regular employees which shall be  
27 supplemental and in addition to those positions authorized in Section 1 of Act  
28 1183 of 1999 and whose salaries shall be governed by the provisions of the  
29 Uniform Classification and Compensation Act (Arkansas Code §§21-5-201 et  
30 seq.), or its successor, and all laws amendatory thereto. Provided, however,  
31 that any position to which a specific maximum annual salary is set out herein  
32 in dollars, shall be exempt from the provisions of said Uniform Classification  
33 and Compensation Act. All persons occupying positions authorized herein are  
34 hereby governed by the provisions of the Regular Salaries Procedures and  
35 Restrictions Act (Arkansas Code §21-5-101), or its successor.

SECTION 2. APPROPRIATION - GENERAL OPERATIONS. There is hereby appropriated, to the Arkansas Livestock and Poultry Commission, to be payable from the Livestock and Poultry Fund Account, for personal services of the Arkansas Livestock and Poultry Commission which shall be supplemental and in addition to those funds appropriated in Section 3 of Act 1183 of 1999, the following:

SECTION 3. REGULAR SALARIES - EGG GRADING PROGRAM. There is hereby established for the Arkansas Livestock and Poultry Commission - Egg Grading Program the following maximum number of regular employees which shall be supplemental and in addition to those positions authorized in Section 7 of Act 1183 of 1999 and whose salaries shall be governed by the provisions of the Uniform Classification and Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and all laws amendatory thereto. Provided, however, that any position to which a specific maximum annual salary is set out herein in dollars, shall be exempt from the provisions of said Uniform Classification and Compensation Act. All persons occupying positions authorized herein are hereby governed by the provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its successor.

SECTION 4. APPROPRIATION - EGG GRADING PROGRAM. There is hereby appropriated, to the Arkansas Livestock and Poultry Commission, to be payable from the Poultry and Egg Grading Fund, for personal services and operating expenses of the Arkansas Livestock and Poultry Commission - Egg Grading Program which shall be supplemental and in addition to those funds appropriated in Section 8 of Act 1183 of 1999, the following:

SECTION 5. APPROPRIATION - LARGE ANIMALS AND POULTRY - SPECIAL. There is hereby appropriated, to the Arkansas Livestock and Poultry Commission, to be payable from the Livestock and Poultry Fund Account, for operating expenses of the Arkansas Livestock and Poultry Commission - Large Animals and Poultry which shall be supplemental and in addition to those funds appropriated in Section 12 of Act 1183 of 1999, the following:

6 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by  
7 this act shall be limited to the appropriation for such agency and funds made  
8 available by law for the support of such appropriations; and the restrictions  
9 of the State Purchasing Law, the General Accounting and Budgetary Procedures  
10 Law, the Revenue Stabilization Law, the Regular Salary Procedures and  
11 Restrictions Act, or their successors, and other fiscal control laws of this  
12 State, where applicable, and regulations promulgated by the Department of  
13 Finance and Administration, as authorized by law, shall be strictly complied  
14 with in disbursement of said funds.

16 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General Assembly  
17 that any funds disbursed under the authority of the appropriations contained  
18 in this act shall be in compliance with the stated reasons for which this act  
19 was adopted, as evidenced by the Agency Requests, Executive Recommendations  
20 and Legislative Recommendations contained in the budget manuals prepared by  
21 the Department of Finance and Administration, letters, or summarized oral  
22 testimony in the official minutes of the Arkansas Legislative Council or Joint  
23 Budget Committee which relate to its passage and adoption.

25 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General  
26 Assembly, that funds provided by the General Assembly for the operations of  
27 the Arkansas Livestock and Poultry Commission are, due to unforeseen  
28 circumstances, insufficient for the Arkansas Livestock and Poultry Commission  
29 to continue to provide essential governmental services; that the provisions of  
30 this act will provide the necessary monies for the Arkansas Livestock and  
31 Poultry Commission to continue such services; and that a delay in the  
32 effective date of this Act could work irreparable harm upon the proper  
33 administration and provision of essential governmental programs. Therefore, an  
34 emergency is hereby declared to exist and this Act being necessary for the  
35 immediate preservation of the public peace, health and safety shall be in full  
36 force and effect from and after the date of its passage and approval.

1 If the bill is neither approved nor vetoed by the Governor, it shall become  
2 effective on the expiration of the period of time during which the Governor  
3 may veto the bill. If the bill is vetoed by the Governor and the veto is  
4 overridden, it shall become effective on the date the last house overrides the  
5 veto.
