16 AN ACT FOR THE DEPARTMENT OF HUMAN  
17 SERVICES - DIVISION OF MENTAL HEALTH  
18 SERVICES APPROPRIATION FOR THE 2001-2003

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
24

25 SECTION 1. REGULAR SALARIES. There is hereby established for the  
26 Department of Human Services - Division of Mental Health Services for the  
27 2001-2003 biennium, the following maximum number of regular employees whose  
28 salaries shall be governed by the provisions of the Uniform Classification  
29 and Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor,  
30 and all laws amendatory thereto. Provided, however, that any position to  
31 which a specific maximum annual salary is set out herein in dollars, shall be  
32 exempt from the provisions of said Uniform Classification and Compensation  
33 Act. All persons occupying positions authorized herein are hereby governed  
34 by the provisions of the Regular Salaries Procedures and Restrictions Act  
35 (Arkansas Code §21-5-101), or its successor.

21 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 22 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MENTAL  
 23 HEALTH SERVICES - ALLOCATION RESTRICTION AND TRANSFER PROVISION. Of the

13 HEALTH SERVICES - GRANTS-IN-AID CONDITIONS FOR RECEIVING FUNDS. Only  
14 locally-operated Centers and Clinics licensed or certified by the Mental  
15 Health Services Division are eligible to receive funds appropriated for  
16 State Assistance in the Mental Health Services - Community Mental Health  
17 Centers appropriation in this Act, and as a condition of receiving such funds  
18 they shall:

19 (1) Meet minimum standards of performance in the delivery of Mental  
20 Health Services as defined by the Department of Human Services, Mental Health

35 provide coordinated care and treatment to ensure ongoing therapeutic  
36 involvement and individualized treatment for persons with long-term, severe

1 mental illness. Every community support program shall use a coordinated case  
2 management system and shall provide or assure access to services for persons  
3 with long-term, severe mental illness who reside within the respective  
4 catchment area of the Center. At a minimum, each community support program  
5 shall provide assessment, diagnosis, identification of persons in need of  
6 services, case management, crisis intervention, psychiatric treatment  
7 including medication services and supervision, counseling and psychotherapy,

25 HEALTH SERVICES - FEDERAL FUNDS. It is the specific intent of the General

 26 SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 27 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MENTAL  
 28 HEALTH SERVICES - VOCATIONAL TRAINEES. The Division of Mental Health  
 29 Services of the Department of Human Services is hereby authorized during the  
 30 ~~1999-2001~~ 2001-2003 biennium to provide employment opportunities for some of  
 31 the working residents who are separate from the currently authorized regular  
 32 vocational trainee positions. The positions authorized herein shall not be  
 33 incorporated into the present classification system but shall be provided for  
 34 by each Community Mental Health Center, or State Hospital, on a cash account  
 35 basis. It is the intent of the General Assembly that the authorization of

6 SECTION 27. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
7 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MENTAL  
8 HEALTH SERVICES - JOB SHARE. The Division of Mental Health Services can  
9 utilize job share for positions within the nursing classification  
10 (RN, LPN/LPTN, MHW/CNA) for up to 24 hours per week per individual. This will  
11 allow the Division to offer weekend option shifts to nursing personnel  
12 without increasing the number of positions.

13  
14 The provisions of this section shall be in effect only from July 1, 2001  
15 through June 30, 2003.

16  
17 SECTION 22. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
18 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MENTAL  
19 HEALTH SERVICES - STATE HOSPITAL CONTINGENCY POSITIONS. If the Department of  
20 Human Services determines, and after prior review by the Legislative Council,  
21 it shall be determined that it is in the best interest of the State of  
22 Arkansas to discontinue a management contract with a private provider and it  
23 is deemed necessary to utilize Department staff to provide the required  
24 services, the Director of the Department of Human Services may request the  
25 Department of Finance and Administration to approve the establishment of one  
26 or more additional positions at salary rates not to exceed the maximum  
27 salaries established for comparable positions in the Uniform Classification  
28 and Compensation Act, the Department of Human Services' Appropriation Act,  
29 and the University of Arkansas for Medical Sciences' Appropriation Act. Upon  
30 approval by the Department of Finance and Administration and after review by

1 SECTION 23. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED  
2 SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND BALANCES. (A) For all  
3 appropriations as provided in this Act, the agency disbursing officer shall  
4 monitor the level of fund balances in relation to expenditures on a monthly  
5 basis. If any proposed expenditures would cause a fund balance to decline to  
6 less than fifty percent (50%) of the balance available on July 1, 2001, the  
7 disbursing officer shall immediately notify the executive head of the agency.  
8 Prior to any obligations being made under these circumstances, the agency  
9 head shall file written documentation with the Chief Fiscal Officer of the  
10 State requesting approval of the expenditures. Such documentation shall  
11 provide sufficient financial data to justify the expenditures and shall  
12 include the following:  
13 1) a plan that clearly indicates the specific fiscal impact of such  
14 expenditures on the fund balance.  
15 2) information clearly indicating and explaining what programs would be cut  
16 or any other measures to be taken by the agency to restore the fund balance.  
17 3) the extent to which any of the planned expenditures are for one-time costs  
18 or one-time purchase of capitalized items.  
19 4) a statement certifying that the expenditure of fund balances will not  
20 jeopardize the financial health of the agency, nor result in a permanent  
21 depletion of the fund balance.  
22 (B) The Chief Fiscal Officer of the State shall review the request and  
23 approve or disapprove all or any part of the request, after having sought  
24 prior review by the Legislative Council.

25  
26 SECTION 24. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized  
27 by this act shall be limited to the appropriation for such agency and funds  
28 made available by law for the support of such appropriations; and the  
29 restrictions of the State Purchasing Law, the General Accounting and  
30 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
31 Procedures and Restrictions Act, or their successors, and other fiscal  
32 control laws of this State, where applicable, and regulations promulgated by  
33 the Department of Finance and Administration, as authorized by law, shall be  
34 strictly complied with in disbursement of said funds.

35  
36 SECTION 25. LEGISLATIVE INTENT. It is the intent of the General Assembly

1 that any funds disbursed under the authority of the appropriations contained  
2 in this act shall be in compliance with the stated reasons for which this act  
3 was adopted, as evidenced by the Agency Requests, Executive Recommendations  
4 and Legislative Recommendations contained in the budget manuals prepared by  
5 the Department of Finance and Administration, letters, or summarized oral  
6 testimony in the official minutes of the Arkansas Legislative Council or  
7 Joint Budget Committee which relate to its passage and adoption.

8  
9 SECTION 26. EMERGENCY CLAUSE. It is found and determined by the General  
10 Assembly, that the Constitution of the State of Arkansas prohibits the  
11 appropriation of funds for more than a two (2) year period; that the  
12 effectiveness of this Act on July 1, 2001 is essential to the operation of  
13 the agency for which the appropriations in this Act are provided, and that in  
14 the event of an extension of the Regular Session, the delay in the effective  
15 date of this Act beyond July 1, 2001 could work irreparable harm upon the  
16 proper administration and provision of essential governmental programs.  
17 Therefore, an emergency is hereby declared to exist and this Act being  
18 necessary for the immediate preservation of the public peace, health and  
19 safety shall be in full force and effect from and after July 1, 2001.
