1	SECTION 4. Upon payment of the fee required by law for registration of		
2	the vehicle, payment of an additional ten-dollar handling and administrative		
3	fee for the issuance of a special license plate, and presentation of proof of		
4	being eligible for a special motor vehicle license plate for county judges,		
5	the Department of Finance and Administration shall issue the appropriate		
6	special license plate to the vehicle owner. The handling and administrative		
7	fee of ten dollars (\$10.00) shall be deposited in the State Central Services		
8	Fund for the benefit of the Revenue Division of the Department of Finance and		
9	Administration and shall be credited to the Revenue Division as supplemental		
10	and in addition to all other funds as may be deposited for the benefit of the		
11	Revenue Division. The handling and administrative fee shall not be considered		
12	or credited to the Revenue Division as "direct revenues".		
13			
14	SECTION 5. Special motor vehicle license plates for county judges may		
15	be renewed annually at the regular fee. Registration may continue from year		
16	to year as long as it is renewed each year within the time and manner required		
17	by Law.
