11 AN ACT TO AMEND ARKANSAS CODE 23-112-607 TO
12 REQUIRE A FIRST-TIME APPLICANT FOR A USED MOTOR
13 VEHICLE DEALER' S LICENSE AFTER JULY 1, 2001 TO
14 ATTEND AN EDUCATIONAL SEMI NAR BEFORE LI CENSURE;

24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25

26 SECTION 1. Arkansas Code 23-112-607(a), concerning the application for
27 a used motor vehicle dealer' s license, is amended to read as follows:

28 (a)(1) Persons wishing to obtain a used motor vehicle dealer' s license
29 shall submit a fully executed application on such used motor vehicle dealer
30 application forms as may be prescribed by the Department of Arkansas State
31 Police.

32 (2) The application shall be verified by the oath or affirmation
33 of the applicant.

34 (3)(A) Beginning July 1, 2001, in addition to the license
35 application required in subdivision (a)(1) of this section, persons who are
36 first time applicants for a used motor vehicle dealer' s license shall attend

1 an educational seminar before being issued a used motor vehicle dealer's
2 license by the department.

3 (B)(i) The seminar shall consist of a six-hour program
4 with the curriculum and faculty approved and supervised by the department.

5 (ii) The fee for conducting the seminar shall be no
6 more than one hundred dollars (\$100).

7 (C) Each educational seminar shall be conducted by a
8 nonprofit corporation authorized to do business in Arkansas.

9 (D) The department shall promulgate rules to implement
10 this subdivision (a)(3).
