Arkansas Code 16-10-308(c)(1) is amended to read as follows: (c)(1) The city administration of justice fund of each city may retain an amount equal to the amount which was collected by the city from court costs and filing fees for city administration of justice expense in the calendar year ending December 31, 1994, or the amount appropriated from court costs and filing fees by ordinance enacted prior to December 31, 1994, for city or county administration of justice expense from court costs and filing fees for the calendar year ending December 31, 1995, plus, for each year after calendar year years 1995 through 2001, an additional amount based upon the average percentage increase in the Consumer Price Index for AII Urban Consumers or its successor, as published by the United States Department of Labor for the two (2) years immediately preceding. The amount retained during calendar year 2002 and each calendar year thereafter shall be the amount retained during calendar year 2001.
