2	(a) Baby Sharon's Children's Catastrophic Illness Grant Program Trust

6	Department of Finance and Administration to accept gifts, grants, bequests,
7	devises, and donations shall be effective on August 1, 2003.

9	26-35-1205. Advisory committee.
10	(a) There is established an advisory committee to be known as the
11	"Baby Sharon's Children's Catastrophic Illness Grant Program Advisory
12	Committee".
13	(b) The committee shall consist of five (5) members to be appointed by

15	(c) The committee members shall be:
16	(1) Individuals who have knowledge of children with catastrophic

9	grant program that assists families of children with catastrophic illnesses

12	Catastrophic Illness Grant Program Advisory Committee concerning:
13	(1) Grant applications related to Baby Sharon's Children's
