2	SECTION 2. (a) Before a gun show vendor may transfer or attempt to
3	transfer a firearm at an organized gun show, the gun show vendor shall obtain
4	approval of the transfer from the Department of Arkansas State Police after
5	the department conducts a background check on the prospective transferee
6	through the Federal Bureau of Investigation's National Instant Criminal
7	Background Check System.
8	(b) A gun show promoter shall prominently post a notice, in a form to
9	be prescribed by the Department of Arkansas State Police, that sets forth the
10	instant background check requirement of this section.
11	(c) This section does not apply to the transfer of an antique firearm
12	as defined in 18 USC 921(a)(16) as it existed December 31, 2002, or a curio
13	or relic as defined in 27 CFR 178.11 as it existed December 31, 2002.
14	(d) Any gun show vendor or promoter who violates this section is
15	guilty of a Class B felony.
