2	SECTION 2. When a person who is delinquent on the payment of an
3	undisputed bill for water service provided by a water system within this
4	state, moves into another area of this state, and that person applies for or
5	receives water from another water system, if the person's former water system
6	establishes that there is no dispute that the delinquent amount is properly
7	due and owed by that particular individual in that amount, the new water
8	system shall refuse to provide water service to the delinquent person until
9	the person provides proof of curing the delinquency.
