SECTION 12. COMPLIANCE WITH OTHER LAWS. 1	SECTION 14. EMERGENCY CLAUSE. It is found and determined by the General
2	Assembly, that the Constitution of the State of Arkansas prohibits the
3	appropriation of funds for more than a two (2) year period; that the

5	the agency for which the appropriations in this Act are provided, and that in
