31	was adopted, as evidence	d by the Agenc	y Request	s, Executive Recommendations		
32	and Legislative Recommen	dations contai	ned in th	e budget manuals prepared by		
33	the Department of Financ	e and Administ	ration, 1	etters, or summarized oral		
34	testimony in the officia	l minutes of t	he Arkans	as Legislative Council or		
35	Joint Budget Committee w	hich relate to	its pass	age and adoption.

1	SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General
2	Assembly, that the Constitution of the State of Arkansas prohibits the
3	appropriation of funds for more than a two (2) year period; that the
4	effectiveness of this Act on July 1, 2003 is essential to the operation of
5	the agency for which the appropriations in this Act are provided, and that in
6	the event of an extension of the Regular Session, the delay in the effective
7	date of this Act beyond July 1, 2003 could work irreparable harm upon the
8	proper administration and provision of essential governmental programs.
9	Therefore, an emergency is hereby declared to exist and this Act being
10	necessary for the immediate preservation of the public peace, health and
11	safety shall be in full force and effect from and after July 1, 2003.
