SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 16 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL 17 ALLOWANCES. For the purpose of providing necessary allowances for housing and other unusual expenses incurred by or in behalf of the athletic director, 18 19 assistant athletic directors, head basketball coaches, and assistant coaches at the University of Arkansas at Little Rock, the Board of Trustees may make 20 21 special allowances available therefor in such amounts as the Board of 22 Trustees may determine as justified, an equitable allowance in view of the 23 unusual and exacting duties of said athletic director, assistant athletic 24 directors, head basketball coaches, and assistant coaches, and for the purpose of providing such allowances, the Board of Trustees is authorized to 25 26 expend from the auxiliary income of the University of Arkansas at Little 27 Rock, which is derived from athletic event receipts, an amount not to exceed 28 twenty thousand dollars (\$20,000) in the aggregate for such purposes during 29 each year of the 2001-2003 2003-2005 biennium for the athletic director and 30 head basketball coaches, and ten thousand dollars (\$10,000) in the aggregate for such purposes during the 2001-2003 2003-2005 biennium for the assistant 31 athletic directors and assistant coaches. 36 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General Assembly
