14	(a) As used in this section, "municipality" means a city of the first		
15	class, a city of the second class, or an incorporated town, or a city or town		
16	department, agency, board, or commission.		
17	(b)(1) Upon receipt of a written request, at least thirty (30) days		
18	before the payroll date, signed by a full time employee who is represented by		
19	a union or professional association, the municipality shall:		
20	(A) Withhold membership dues of the union or professional		
21	association from the salary of the municipal employee; or		
22	(B) Respond in writing to the employee or to the union or		
23	the professional association stating why the request will not be granted.		
24	(2) The withholding request authorized by this section shall be		
25	on a form provided to the employee by the municipality.		
26	(c) After a withholding request is received by the municipality and		
27	after withholding of an employee's dues is started under subsection (b) of		
28	this section, the withholding shall be discontinued only upon receipt of a		
29	written notice of cancellation signed by the employee.		
30	(d) At the end of each month, the municipality shall transmit all dues		
31	that are withheld under this section to the union or professional association		
32	representing the city or town employee.
