## For An Act To Be Entitled

9 AN ACT TO AMEND ARKANSAS CODE TITLE 27, CHAPTER  
10 15 TO ADD AN ADDITIONAL SUBCHAPTER TO PROVIDE FOR  
11 THE ISSUANCE OF A BOY SCOUTS OF AMERICA SPECIAL  
12 LICENSE PLATE TO ACKNOWLEDGE THEIR PUBLIC  
13 SERVICE; AND FOR OTHER PURPOSES.

## Subtitle

15 TO PROVIDE FOR THE ISSUANCE OF A BOY  
16 SCOUTS OF AMERICA SPECIAL LICENSE PLATE  
17 TO ACKNOWLEDGE THEIR PUBLIC SERVICE.

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
22

23 SECTION 1. Arkansas Code Title 27, Chapter 15, is amended to add an  
24 additional subchapter to read as follows:

25 Subchapter 39 - Boy Scouts of America License Plate

26  
27 27-15-3901. Boy Scouts of America license plate authorized.

28 The Director of the Department of Finance and Administration shall  
29 provide for and issue Boy Scouts of America special license plates in the  
30 manner and subject to the conditions under this subchapter.  
31

32 27-15-3902. Plate design.

33 (a)(1) The special motor vehicle license plates shall be designed by  
34 the Boy Scouts of America, Quapaw Area Council of Arkansas.

35 (2) The design shall be submitted for design approval by the  
36 Director of the Department of Finance and Administration under rules and



1 regulations of the director.

2 (3) The Boy Scouts of America, Quapaw Area Council of Arkansas  
3 may periodically submit a newly designed license plate for approval and issue  
4 by the director of the department, with not more than one (1) license plate  
5 new design issued per calendar year.

6 (b)(1) Upon approval of the design by the Director of the Department  
7 of Finance and Administration, the Boy Scouts of America, Quapaw Area Council  
8 of Arkansas shall remit to the department a fee in the amount of six thousand  
9 dollars (\$6,000) to cover the cost of the initial order of each newly  
10 designed license plate.

11 (2) This fee shall be deposited to the State Central Services  
12 Fund for the benefit of the Revenue Division of the Department of Finance and  
13 Administration and shall be credited as supplemental and in addition to all  
14 other funds as may be deposited for the benefit of the division.

15 (3) The fee shall not be considered or credited to the division  
16 as direct revenues.

17 (c) The director of the department shall promulgate reasonable rules  
18 and regulations and prescribe any forms as the director determines to be  
19 necessary to carry out the intent and purposes of this subchapter.

21 27-15-3903. Transfer to another vehicle.

22 Special Boy Scouts of America license plates issued under this  
23 subchapter may be transferred from one vehicle to another under § 27-14-914.

24  
25 27-15-3904. Compliance with other laws.

26 The special Boy Scouts of America license plates shall comply with all  
27 other state motor vehicle laws relating to registration and licensing of  
28 motor vehicles, including the minimum number of license plate applications  
29 required under § 27-15-4004, except as specifically provided otherwise in  
30 this subchapter.
