36	SECTION 2. Students who have been placed at risk of academic failure;

1	Personal education plans.
2	(a)(l) Local school districts shall identify students in all grades
3	who have been placed at risk for academic failure and shall implement a
4	personal education plan for academic improvement with focused intervention
5	and performance benchmarks.
6	(2) Identification shall occur as early as can reasonably be
7	done and can be based on grades, observations, and other factors that
8	teachers and administrators consider appropriate, without having
9	to await the results of end-of-grade or end-of-course tests.
10	(b)(1) At the beginning of the school year a personal education plan
11	shall be developed for any student not performing at least at grade level, as
12	identified by the state end-of-grade test.
13	(2) If a student's performance appears to be falling below state
14	proficiency standards at any time during the school year, a personal
15	education plan shall be developed.
16	(c) Focused intervention and acceleration activities may include,
17	among other things, summer school, Saturday school, and extended days.
18	(d) Local school districts shall provide the activities identified in
19	subdivision (c) of this section, and transportation, free of charge to
20	students.
21	
22	SECTION 3. Establishment of Local Task Forces on Closing the
23	Achievement Gap.
24	(a)(1) The State Board of Education shall adopt a policy for local
25	school district to establish local task forces on closing the achievement
26	gap.
27	(2) The purpose of each task force is to advise and work with
28	its local board of directors and administration on closing the gap in
29	academic achievement and on developing a collaborative plan for achieving
30	that goal.
31	(b) The policy shall include the following:
32	(1) Each task force shall report to its local board of
33	<u>directors;</u>
34	(2) Each task force shall include key stakeholders in the
35	community who are committed to improving the education of all children,
36	especially those who are underachieving, and who agree to attend, on a

1	regular basis, task force meetings, take an active role in discussions and
2	activities, listen to the ideas, suggestions, and comments of other task
3	force members as well as community members, inform other members of the
4	school and community of the work of the task force, participate in any
5	training for the task force members such as consensus building, problem-
6	solving, and group dynamics, and seek actively data-driven solutions to
7	improving the achievement of all students; and
8	(3) Task force members shall be representative of community
9	demographics, race, ethnic, gender, and socio-economic diversity, and it is
10	strongly recommended that they include:
11	(A)(i) Three (3) parents, as selected by the local school
12	district's parent organization.
13	(ii) One (1) parent who has a child at an elementary
14	school, one (1) who has a child at a junior high or middle school, and one
15	(1) who has a child at a high school;
16	(B) School administrators, teachers, instructional support
17	personnel, exceptional children personnel, and second language specialists,
18	each of whom shall be selected by the superintendent;
19	(C) One (1) member of the local board of education, as
20	selected by that board;
21	(D) One (1) representative of the local department of
22	social services;
23	(E) At least one (1) juvenile court counselor;
24	(F) At least one (1) representative of local law
25	enforcement;
26	(G) One (1) representative of the local Communities in
27	Schools program, if present in the local school district, as selected by the
28	executive director of that program;
29	(H) At least one (1) representative of local businesses,
30	as selected by the local chamber of commerce;
31	(I) Representatives from community-based organizations, as
32	selected by the superintendent upon recommendation from those organizations;
33	(J) At least one (1) representative of a university school
34	of education, if there is one in the area, as selected by the chairperson of
35	the local board of education;
36	(K) Two (2) high school students, as recommended by their

1	student councils and elected by the chairperson of the local board of
2	education; and
3	(L) Any other community representatives, as selected by
4	the superintendent.
5	(c) The superintendent shall name the chair of the task force, who
6	shall call the first meeting of the task force.
7	(d) Each task force shall:
8	(1) Decide on training that it may need;
9	(2) Determine what information and data the task force will
10	need, plan and schedule presentations on the information and data, which
11	shall be disaggregated by race, ethnicity, gender, and socio-economic status.
12	Examples may include state test data, discipline statistics, teacher-student
13	ratio, student and teacher attendance data, faculty composition by race,
14	gender, and ethnicity, and professional preparation of educators;
15	(3) Define the communication process and person responsible for
16	disseminating information to the public. Communication shall include the
17	posting of information on a website and shall provide appropriate
18	translations, as needed;
19	(4) Establish a policy statement on closing the achievement gap
20	for the local school administrative unit. This statement shall address why
21	closing the achievement gap is important to the entire community;
22	(5)(A) Set aside specific meetings to analyze and synthesize
23	data and information.
24	(B) The task force shall use the data to identify and
25	prioritize the problems with student achievement;
26	(6) Identify and review current effective programs and
27	instructional strategies that address student achievement needs, identify
28	criteria used to determine their effectiveness, determine changes to improve
29	the effectiveness, identify gaps in services, identify needed information to
30	determine research-based programs and strategies that are effective in
31	addressing the gaps; and
32	(7) Develop a report to the school and community that includes
33	an implementation plan, benchmarks, and the monitoring process.
34	(e)(1) Each task force may establish subcommittees to research answers
35	to the critical questions.
36	(2) If subcommittees are established, they shall present their

           (a) The State Board of Education shall report annually to the Joint

     Interim Oversight Committee on Education Reform and the Committee on Closing

     the Academic Achievement Gap in Arkansas on the numbers of students who have
     dropped out of school, been suspended, been expelled, or placed in an
14

     alternative program.

           (b) The data shall be reported in a disaggregated manner and be
17
     readily available to the public.

           (c) The state board shall not include students that have been expelled
     from school when calculating the dropout rate.
