| 26 | instrument into the head of the fetus and aspirates the central nervous |
| 27 | system with suction, collapsing the head and then extracts the fetus intact; |

| 31 | is turned to that position, the physician then performs a breech delivery, |

| 34 | the base of the fetal skull and aspirates the central nervous system, |
