1 WHEREAS, the State of Arkansas established the Arkansas Natural and 2 Cultural Resources Council in 1987 to dispense funds received from the real 3 estate transfer taxes to preserve state historic properties and the Council 4 works with the National Trust for Historic Preservation to preserve our 5 states historic structures and traditional sites; and 6 7 WHEREAS, the State of Arkansas spends almost twenty million dollars 8 (\$20,000,000) annually to promote preservation efforts by the state and local 9 governments and to educate the private business sector and the public 10 citizenry about the importance of preserving historic places and buildings 11 and promoting cultural resources; and 12 13 WHEREAS, historic structures and traditional sites of Arkansas are so 14 extremely important to our economy, as more than history when historic 15 buildings and archeological sites serve as magnets for tourism and economic 16 development, and when cultural assets and heritage sites are recognized by 17 business leaders as community assets to attract business development and to 18 enrich our cultural appreciation, 19 20 NOW THEREFORE, 21 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-FOURTH GENERAL 22 ASSEMBLY OF THE STATE OF ARKANSAS, THE SENATE CONCURRING THEREIN: 23 24 That the great State of Arkansas acknowledge its great historic 25 heritage and its cultural treasures and should set the highest example of 26 preserving our historic structures and cultural sites by insisting that 27 publicly-owned buildings are these kinds of assets that must be managed by 28 the best preservation principles. 29 30 BE IT FURTHER RESOLVED that all publicly-owned historic structures and sites 31 should not undergo any alteration that would compromise the historic 32 integrity without: 33 First a public announcement of the intent and goals of the alteration 34 or renovation project; and 35 Second, a review conducted in accordance with state and national 36 preservation guidelines under the direction of the Arkansas Historic

1	Preservation Program or a private consultant to insure that taxpayer money is
2	spent to enhance the historic property and not compromise the integrity of
3	the historic structure or site.
