26	WHEREAS, the people of the State of Arkansas have amended the Arkansas	
27	Constitution to limit their Representatives to Congress to serving three two-	
28	year terms and their Senators to Congress to serving two six-year terms; and	
29		
30	WHEREAS, other states limit the terms their delegations to Congress may	
31	serve; and	
32		
33	WHEREAS, the United States Supreme Court decreed in the case of U.S.	
34 25	Term Limits, Inc. vs. Thornton, that terms of members elected to the United	
35	States Congress may be limited only by Amendment to the United States	
36	Constitution; and

2	WHEREAS, the people of the various States have consistently
3	demonstrated, at the ballot box and in opinion polls, their overwhelming
4	desire to limit the terms of members serving in the United States Congress;
5	and
6	
7	WHEREAS, under Article V of the Constitution of the United States,
8	amendments to the Federal Constitution may be proposed by the Congress
9	whenever two thirds of both Houses deem it necessary, or on the application
10	of the legislatures of two thirds of the several states the Congress shall
11	call a Convention for the purpose of proposing amendments; and
12	
13	WHEREAS, we believe such action vital;
14	
15	NOW THEREFORE,
16	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-FOURTH GENERAL
17	ASSEMBLY OF THE STATE OF ARKANSAS AND BY THE SENATE, A MAJORITY OF ALL
18	MEMBERS ELECTED TO EACH HOUSE AGREEING THERETO:
19	
20	That this body proposes to the Congress of the United States that
21	procedures be instituted in the Congress to add a new Article to the
22	Constitution of the United States, and that the General Assembly of the State
23	of Arkansas requests the Congress to prepare and submit to the several states
24	an amendment to the Constitution of the United States, to limit the terms of
25	Representatives and Senators serving in the United States Congress; and
26	
27	BE IT FURTHER RESOLVED that, alternatively, this body makes application
28	and requests that the Congress of the United States call a Convention for
29	proposing amendments to the United States Constitution; and
30	
31	BE IT FURTHER RESOLVED that this body also proposes that the
32	legislatures of each of the several states comprising the United States apply
33	to the Congress requesting the proposal of an appropriate amendment to the
34	Federal Constitution, or requiring the Congress to call a Convention for
35	proposing such an amendment to the Federal Constitution; and
