19	the advisory committee after the college was investigated and found to meet
20	the acceptable education standards in existence at the time of the
21	applicant's graduation; and
22	(3) The applicant produces evidence satisfactory to the advisory
23	committee that the applicant holds a valid, unsuspended, and unrevoked
24	license, has been actively engaged in the practice of naturopathy for not
25	less than one (1) year; and
26	(4) Is of good moral character.
27	(c) A person may sit for the examination prescribed or endorsed by the

29	(a) A license to practice as a naturopathic physician shall be renewed
30	annually.
31	(b) To renew a license, each naturopathic physician shall submit to
32	the Department of Health evidence of successful completion of the required
33	hours of continuing education from programs approved by the State Board of
34	Health.
35	(c) The board shall adopt rules establishing approved programs of
36	continuing education and the manner for verifying participation.

1	(d) The board may adopt other rules necessary to the administration of
2	license renewals.
3	
4	17-107-306. Continuing education.
5	(a)(1) The State Board of Health shall require not fewer than fifteen
6	(15) hours annually of continuing education hours for all naturopathic
7	physicians.
8	(2) The board shall require not fewer than fifteen (15) hours
9	annually of specialty instruction in obstetrics or natural childbirth and not
10	fewer than twenty (20) hours biennially for a total of not fewer than thirty-
11	five (35) hours biennially for a naturopathic physician certified in
12	naturopathic childbirth.
13	(b)(1) A person who seeks to renew a license that expired within the
14	preceding year shall comply with the continuing education requirements for
15	the regular renewal of the license.
16	(2) A person seeking to renew a license that has been expired
17	for more than one (1) year must present evidence of completion of not less
18	than one-half $(1/2)$ of the required hours of approved continuing education
19	requirements during the year preceding the date of the application for
20	renewal.
21	
22	17-107-307. Inactive status - retired status.
23	(a) To place a license on inactive status, the license holder must
24	notify the Department of Health at the time of renewal and pay a fee for
25	inactive status.
26	(b) To activate a license on inactive status, the license holder must
27	pay the regular renewal fee and present evidence of having completed not less
28	than one-half $(1/2)$ of the required hours of approved continuing education
29	requirements during the year preceding the date of the application for
30	activation.
31	(c)(l) A license holder seeking to place a license on retired status
32	must notify the department at the time of renewal.
33	(2) A license on retired status may not be reactivated.
34	(d) A license holder who holds a license that is on inactive or
35	retired status may not practice naturopathic medicine.

1	SUBCHAPTER 4 - THE NATUROPATHIC MEDICINE ACT - NATUROPATHIC PRACTICE
2	
3	17-107-401. Authorized activities.
4	(a) A person licensed as a naturopathic physician under this chapter
5	may use for preventive and therapeutic purposes the following preparations
6	and therapies:
7	(1) Natural medicines;
8	(2) Minor office procedures;
9	(3) Natural antibiotics;
10	(4) Naturopathic medicine;
11	(5) Naturopathic childbirth;
12	(6) Naturopathic mobilization therapy;
13	(7) Topical preparations; and
14	(8) Naturopathic physical medicine.
15	(b) A person licensed as a naturopathic physician under this chapter
16	may use for evaluation purposes:
17	(1) Physical and orificial examinations;
18	(2) X-rays;
19	(3) Electrocardiograms;
20	(4) Therapeutic ultrasound;
21	(5) Phlebotomy;
22	(6) Clinical laboratory tests and examinations;
23	(7) Physiological function tests; and
24	(8) The noninvasive diagnostic procedures commonly used in
25	general practice.
26	
27	<u>17-107-402. Specialty practice.</u>
28	(a)(1) A naturopathic physician may not practice naturopathic
29	childbirth without obtaining a certificate of specialty practice in
30	naturopathic childbirth.
31	(2) The State Board of Health shall promulgate rules to certify
32	naturopathic physicians for specialty practice.
33	(b) To be certified in naturopathic childbirth, a naturopathic
34	physician shall:
35	(1) Pass a specialty examination in obstetrics or natural
36	childbirth recommended by the Naturopathic Physicians Advisory Committee; and

1	(2) Comply with the requirements adopted by the board for
2	issuance of the specialty certification that are equivalent to the minimum
3	requirements, including any examination requirements, to obtain a license to
4	practice midwifery in this state.
5	(c) The advisory committee may recommended a national standardized
6	examination in obstetrics or natural childbirth as constituting the specialty
7	examination.
8	
9	<u>17-107-403. Use of X-ray.</u>
10	(a) A naturopathic physician licensed under this chapter may use an X-
11	ray in the course of practice only if the naturopathic physician is certified
12	by the State Board of Health as qualified to perform X-ray procedures.
13	(b) The board shall adopt rules for the issuance of a certification
14	under this section that are equivalent to the requirements for other health
15	professionals to engage in the use of X-rays.
16	
17	17-107-404. Prohibited Acts.
18	<u>A naturopathic physician may not:</u>
19	(1) Prescribe, dispense, or administer any legend drugs or controlled
20	substances except those preparations authorized by this chapter or State
21	Board of Health rule;
22	(2) Perform surgical procedures or X-ray procedures except those
23	procedures authorized by this chapter or board rule;
24	(3) Practice emergency care except as a Samaritan rendering gratuitous
25	services in the case of emergency, and except for the care of minor injuries;
26	or
27	(4) Claim to practice allopathic medicine or surgery, osteopathy,
28	dentistry, podiatry, optometry, chiropractic, physical therapy, acupuncture,
29	or any other system or method of treatment not authorized by this chapter or
30	board rule.
31	
32	17-107-405. Duties and responsibilities.
33	<u>A naturopathic physician has the same responsibility as any other</u>
34	licensed health care provider regarding public health laws, reportable
35	diseases and conditions, communicable disease control and prevention, the
36	recording of vital statistics, health and physical examinations, and

1	competency examinations, except that the authority under this section is	
2	limited to activity consistent with the scope of practice authorized by this	
3	<u>chapter.</u>
