Disbursement of funds authorized 19 by this act shall be limited to the appropriation for such agency and funds 20 21 made available by law for the support of such appropriations; and the 22 restrictions of the State Purchasing Law, the General Accounting and 23 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 24 Procedures and Restrictions Act, or their successors, and other fiscal 25 control laws of this State, where applicable, and regulations promulgated by 26 the Department of Finance and Administration, as authorized by law, shall be 27 strictly complied with in disbursement of said funds.
