34	(A)(i)(<u>a)</u> Employed in an employee-employer relationship;

2	(B)(ii) Not in the employ of another law enforcement
3	officer; <u>or</u>
4	(B) Working under the Department of Arkansas State Police
5	which is the security service contactor;

7	SECTION 2. The Department of Arkansas State Police may engage in the
8	business of, and perform the services of a security services contractor, and
9	is exempt from the licensing requirements under the Private Investigators and
10	<u>Private Security Agencies Act, §§ 17-40-101 et seq.</u>
