SECTION 3. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CONTRACTUAL SERVICES LIMITED. No more than \$75,000 \$78,750 of the funds appropriated for Professional Fees and Services may be expended in the 2001—2002 2003-2004 fiscal year, and no more than \$75,000 \$82,500 of the funds may be expended in the 2002-2003 2004-2005 fiscal year for contractual services

- 1 of an attorney to represent the Commission when reviewing cases of judicial
- 2 misconduct. Provided further, none of these funds shall be spent for
- 3 contractual services of an attorney until it has been determined by the

- 8 SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized

- 18 SECTION 5. LEGISLATIVE INTENT. It is the intent of the General Assembly

- 21 was adopted, as evidenced by the Agency Requests, Executive Recommendations
- 22 and Legislative Recommendations contained in the budget manuals prepared by
- 23 the Department of Finance and Administration, letters, or summarized oral
- 24 testimony in the official minutes of the Arkansas Legislative Council or

- 27 SECTION 6. EMERGENCY CLAUSE. It is found and determined by the General
- 28 Assembly, that the Constitution of the State of Arkansas prohibits the
- 29 appropriation of funds for more than a two (2) year period; that the
- 30 effectiveness of this Act on July 1, 2003 is essential to the operation of
- 31 the agency for which the appropriations in this Act are provided, and that in
- 32 the event of an extension of the Regular Session, the delay in the effective
- 33 date of this Act beyond July 1, 2003 could work irreparable harm upon the
