10	(C) Be justified by compelling reasons and special

14	(3) $(\Lambda)$ An order denying visitation rights to grandparents and				
15	great-grandparents shall be in writing and shall state the reasons for				
16	denial.				
17	(B) An order denying visitation rights is a final order				
18	for purposes of appeal.				
19	(b) If the court denies the petition requesting grandparent or great-				
20	grandparent visitation rights and determines that the petition for				
21	grandparent or great-grandparent visitation rights is not well-founded, was				
22	filed with malicious intent or purpose, $\frac{\partial \mathbf{r}}{\partial t}$ and that granting grandparent or				
23	great-grandparent visitation rights is not in the best interest and welfare				
24	of the child, would cause harm to the child, or would interfere with the				
25	parent-child relationship, the court may, upon motion of the respondent,				
26	order the petitioner to pay reasonable attorney's fees and court costs to the				
27	attorney of the respondent, after taking into consideration the financial				
28	ability of the petitioner and the circumstances involved.				
29	(c) The provisions of subsections (a) and (b) of this section shall
