35 36	facility to deliver the application, obtain a ballot, and deliver the ballot

1 (3) "Automatic tabulating equipment" means apparatus necessary 2 to automatically examine and count votes as designated on vote cards and data 3 processing machines which can be used for counting votes and tabulating 4 results but shall not include those voting machines authorized under this 5 title; 6 (4) "Candidate and issue labels" means the cards, paper, 7 booklet, pages, or other material containing the names of offices and 8 candidates and statements of measures to be voted on; 9 (5) "Canvassing" means examining and counting the returns of 10 votes cast at a public election to determine authenticity; 11 (6) "Constitutional officers of this state" means the offices of 12 the Governor, Lieutenant Governor, Secretary of State, Attorney General, Auditor of State, Treasurer of State, and Commissioner of State Lands; 13 14 (7) "Counting location" means a location selected by the county 15 board of election commissioners with respect to all elections for the 16 automatic processing or counting or both of votes; 17 (8) "Designated bearer" means any person who is identified and authorized by the applicant to obtain from the county clerk or to deliver to 18 19 the county clerk the applicant's ballot; "Election official" or "election officer" means a person who 20 (9) 21 is a member of the county board of election commissioners or a person who is 22 a poll worker, having been designated by a county board of election 23 commissioners to be an election clerk, election judge, or election sheriff; 24 (10) "Electronic voting system" means a system of casting votes 25 by use of marking devices and tabulating votes by use of automatic tabulating 26 equipment or data processing equipment but shall not include those voting 27 machines authorized under this title; 28 "Fail-safe voting" means the mechanism established under (11)the National Voter Registration Act of 1993 that allows voters who have moved 29 30 within the same county to vote at their new precinct without having updated 31 their voter registration records; 32 "First-time voter" means any registered voter who has not (12) 33 previously voted in a federal election in the state. 34 (12)(13) "General or special election" means the regular 35 biennial or annual elections for election of United States, state, district, 36 county, township, and municipal officials and the special elections to fill

12 (15)(16) "Minority party" means that political party whose 13 candidates were elected to less than a majority of the constitutional offices 14 of this state in the last-preceding general election or the political party 15 which polled the second-greatest number of votes for the office of Governor 16 in the last-preceding general election if all of the elected constitutional 17 officers of this state are from a single political party;

18 (16)(17)(A) "Political party" means any group of voters which at 19 the last-preceding general election polled for its candidate for Governor in 20 the state or nominees for presidential electors at least three percent (3%) 21 of the entire vote cast for the office.

(B) No group of electors shall assume a name or designation which is so similar in the opinion of the Secretary of State to that of an existing political party as to confuse or mislead the voters at an election.

(C) When any political party fails to obtain three percent

31 (18)(19) "Precinct" means the geographical boundary lines 32 dividing a county, municipality, township, or school district for voting 33 purposes;

34 (19)(20) "Primary election" means any election held by a
 35 political party in the manner provided by law for the purpose of selecting
 36 nominees of said political party for certification as candidates for election

1 at any general or special election in this state;

2 (20)(21) "Qualified elector" means a person who holds the
3 qualifications of an elector and who is registered pursuant to Arkansas
4 Constitution, Amendment 51;

5 (21)(22) "Vacancy in election" means the vacancy in an elective 6 office created by death, resignation, or other good and legal cause, arising 7 prior to election to the office at a general or special election but arising 8 subsequent to the certification of the ballot;

9 (22)(23) "Vacancy in nomination" means the circumstances in 10 which the person who received the majority of votes at the preferential 11 primary election or general primary election cannot accept the nomination due 12 to death or notifies the party that he or she will not accept the nomination 13 due to serious illness, moving out of the area from which the person was 14 elected as the party's nominee, or filing for another office preceding the 15 final date for certification of nominations;

16 (23)(24)(A) "Vacancy in office" means the vacancy in an elective 17 office created by death, resignation, or other good and legal cause arising 18 subsequent to election to the office at a general or special election or 19 arising subsequent to taking office and prior to the expiration of the term 20 of office in those circumstances wherein the vacancy must be filled by a 21 special election rather than by appointment.

7	(2) The county board of election commissioners shall transmit
8	the information required according to subsection (a) of this section to the
9	county clerk who shall enter and transmit it to the State Board of Election
10	Commissioners through the Secretary of State internet website interface.

12	SECTION 14. Arkansas Code § 7-4-101(f), concerning the state board of
13	election commissioners, is amended to read as follows:
14	(f) The state board shall perform the following duties:
15	(1) Publish a candidate's election handbook, in conjunction with
16	the office of the Secretary of State and the Arkansas Ethics Commission,
17	which outlines in a readable and understandable format the legal obligations
18	of a candidate and any other suggestions that might be helpful to a candidate
19	in complying with state election law;
20	(2) Conduct statewide training for election officials and county
21	election commissioners;
22	(3) Adopt all necessary rules and regulations regarding training
23	referred to in subdivision (f)(2) of this section and develop procedures for
24	monitoring attendance;
25	(4) Monitor all election law-related legislation;
26	(5) Review citizen complaints regarding violations of election
27	and voter registration laws and forward them to the proper authorities,
28	except as to § 7-1-103(a)(1)-(4), (6), and (7) or except for any matter
29	relating to campaign finance and disclosure laws, which the Arkansas Ethics
30	Commission shall have the same power and authority to enforce as is provided
31	the commission under §§ 7-6-217 and 7-6-218 for the enforcement of campaign
32	finance laws;
33	(6) Develop procedures for reviewing and forwarding citizen
34	complaints referred to in subdivision (f)(5) of this section;
35	(7) Formulate, adopt, and promulgate all necessary rules and
36	regulations to assure even and consistent application of voter registration

1 laws and fair and orderly election procedures; 2 (8)(A) Appoint certified election monitors to any county upon a 3 signed, written request under oath filed with the state board and a 4 determination by the state board that appointing a monitor is necessary. 5 (B) Certified election monitors shall serve as observers 6 for the purpose of reporting to the state board on the conduct of the 7 election. 8 The state board may allow for reasonable compensation (C) 9 for election monitors: 10 (9) Assist the county board of election commissioners in the 11 performance of the administrative duties of the election process if the state 12 board determines that assistance is necessary and appropriate; (10)(A) Formulate, adopt, and promulgate all necessary rules and 13 regulations to establish uniform and nondiscriminatory administrative 14 15 complaint procedures consistent with the requirements of Title IV of the 16 federal Help America Vote Act. 17 (B) The cost of compliance with Title IV of the federal Help America Vote Act shall be paid from the fund established to comply with 18 19 the federal Help America Vote Act. (10) (11) If the state board finds a violation of election and 20 voter registration laws, except as to (7-1-103(a)(1)-(4)), (6), and (7), or 21 22 except for any matters relating to campaign finance and disclosure laws which 23 the commission shall have the same power and authority to enforce under §§ 7-24 6-217 and 7-6-218 for the enforcement of campaign finance laws, the state 25 board may do one (1) or more of the following: 26 (A) Issue a public letter of caution or warning or 27 reprimand; 28 (B)(i) Impose a fine of not less than twenty-five dollars 29 (\$25.00) nor more than one thousand dollars (\$1,000) for negligent or 30 intentional violation of this subchapter. 31 (ii) The state board shall adopt rules governing the imposition of such fines in accordance with the provisions of the Arkansas 32 33 Administrative Procedure Act, § 25-15-201 et seq. 34 (iii) All moneys received by the state board in 35 payment of fines shall be deposited in the State Treasury as general 36 revenues; or

(C) Report its finding, along with such information and documents as it deems appropriate, and make recommendations to the proper law enforcement authorities; (11) (12) The state board shall complete its investigation of a complaint filed pursuant to this section within no later than ninety (90) days of the filing of the complaint; and $\frac{(12)}{(13)}$ Any final action of the state board under this section shall constitute an adjudication for purposes of judicial review under § 25-15-212. /s/ Faris
