10 AN ACT TO INCREASE THE ELEVATOR INSPECTION FEES;  
11 TO STANDARDIZE THE FEE SCHEDULES FOR OPERATING  
12 PERMITS FOR SPECIAL ELEVATORS; TO AUTHORIZE  
13 TEMPORARY OPERATING PERMITS; AND FOR OTHER  
14 PURPOSES.

16 AN ACT TO INCREASE THE ELEVATOR  
17 INSPECTION FEES; TO STANDARDIZE THE FEE  
18 SCHEDULES FOR ELEVATORS; AND TO

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25 SECTION 1. Arkansas Code § 20-24-113(c), concerning elevator  
26 inspection fees, is amended to read as follows:

27 (c)(1) For each inspection and report made at the direction of the  
28 department, the owner, lessee, or insurance company responsible for the  
29 report of inspection shall pay to the department a fee of ~~fifty dollars~~  
30 ~~(\$50.00)~~ one hundred dollars (\$100), unless otherwise provided by the board,  
31 ~~plus mileage allowance prescribed by state travel regulations in going to and~~  
32 ~~returning from the point of inspection and all actual expense for meals and~~  
33 ~~lodging incurred in making the inspection.~~

34 (2) The fee ~~and expenses~~ shall be paid directly to the  
35 department and shall be the only fees or charges for which such owner,  
36 lessee, or insurance company shall be liable for the inspection required by §

3 SECTION 2. Arkansas Code § 20-24-116(a)(4)(A), concerning operating  
4 permits, is amended to read as follows:

5 (4)(A) The annual fee to be charged for the operating permit  
6 issued under the provisions of this chapter shall be as follows:

8 (i) Dumbwaiters \$30.00 annual

18 subsections to read as follows:

19 (e)(1) The department may, pursuant to regulation of the board, issue  
20 a temporary certificate of operation for a period not to exceed ninety (90)  
21 days for new installations.

22 (2) The fee for a temporary certificate of operation shall be  
23 established by the board in an amount not to exceed one hundred dollars  
24 (\$100).

25 (f) An application for a variance shall be submitted to the department  
26 with the fee established by the board in an amount not to exceed one hundred  
27 dollars (\$100).

29 SECTION 4. Arkansas Code § 20-24-117 is amended to read as follows:

30 (a) The following fees shall be paid to the Department of Labor for  
31 each passenger, freight, one-man elevator, or dumbwaiter installation permit:

11 (b) A fee of not less than five dollars (\$5.00) and not more than one

13 permits for all other types of elevators, escalators, power lifts, or moving  
14 walks. ~~These fees will be applicable as follows:~~

15 ~~(1) An installation permit for an escalator or workmen's hoist~~  
16 ~~shall be issued upon payment of the fee of one hundred dollars (\$100) or as~~  
17 ~~otherwise prescribed by the board;~~

18 ~~(2)(c)~~ A final inspection fee and the fee for the initial  
19 operating permit ~~is~~ are included in the installation permit fee. If a  
20 scheduled final inspection is cancelled without due notice to the department  
21 or if the elevator is not complete in the judgment of the ~~general inspection~~  
22 inspector, an additional fee of ~~fifty dollars (\$50.00) plus expenses~~ one  
23 hundred dollars (\$100) shall be charged to the elevator contractor for an  
24 additional final inspection.

25 ~~(e)(d)~~ Major alterations may be made upon obtaining a permit  
26 which requires a payment of a ~~sixty dollar (\$60.00)~~ one hundred dollar (\$100)  
27 fee.

28 ~~(d)(e)~~ A fee of ~~fifty dollars (\$50.00) plus expenses~~ seventy-  
29 five dollars (\$75.00), or as otherwise prescribed by the board, shall be paid  
30 to the department for witnessing the performance of all safety tests as  
31 outlined in §§ 20-24-112 – 20-24-114.
