18	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20	SECTION 1. Arkansas Code § 26-52-103(a)(3), pertaining to th	e	
21	definition of sale for purpose of the Arkansas Gross Receipts Act o		is
22	amended to add a new subdivision to read as follows:		
23	(F) "Sale" shall not include the transfer of tit	le to a	<u>:</u>
24	vehicle by the vehicle owner to an insurance company as a result of	the	
25	settlement of a claim for damages to the vehicle.

27	SECTION 2. EMERGENCY CLAUSE. It is found and determined by	<u>the</u>	
28	General Assembly of the State of Arkansas that current law excludes	the	
29	transfer of a damaged vehicle to an insurance company from the defi	nition	<u>of</u>
30	"sale" for purposes of gross receipts tax; that this definition is	in need	of
31	clarification to ensure that the original legislative intent is ful	filled;	-
32	and that this act is immediately necessary to prevent possible conf	usion	
33	among the taxpayers of Arkansas. Therefore, an emergency is declar	ed to	
34	exist and this act being immediately necessary for the preservation	of the	<u>.</u>
35	public peace, health, and safety shall become effective on:		
36	(1) The date of its approval by the Governor;		

1	(2) If the bill is neither approved nor vetoed by the Governor,
2	the expiration of the period of time during which the Governor may veto the
3	bill; or
4	(3) If the bill is vetoed by the Governor and the veto is
5	overridden, the date the last house overrides the veto.
